Good Afternoon AG Formella and Coos County Attorney McCormick:

I am writing, once again, to request an investigation into recent allegations of illegal activities centered around the Casella project in Dalton, New Hampshire. Two elected officials, Tom Dubreuil and Eric Moore, have consistently violated New Hampshire and Federal statutes, including RICO. This would include illegal meetings, in violation of RSA 91-A Right-To-Know Law, in order to help facilitate public approval in the form of a Host Community Agreement (HCA) for the benefit of Casella's Granite State Landfill (GSL) project in Dalton, New Hampshire.

Public dollars have been admittedly expended by elected officials for unauthorized legal services, seemingly to help the two elected officials facilitate HCA approval for the GSL landfill project of Casella Waste Systems of Rutland, Vermont, despite a Special Town Meeting about this very matter last year.

Public corruption and interstate commerce would seem to fit the bill for the RICO statutes, in my opinion.

As evidenced in the below-linked video excerpt of the February 2, 2026 Town of Dalton Selectboard meeting, Selectman Tom Dubreuil is accused, by another citizen, of illegal behavior(s). Selectman Dubreuil acknowledges such, admitting to speaking with the town attorney, without board approval, (see attached BOS Rules of Procedure, Section IV, C2), resulting in the expenditure of public taxpayer monies to facilitate entering the Town of Dalton into a legal agreement with Casella Waste Systems. Also see Town of Dalton HCA Committee meeting minutes, 11/3/2025 and 2/2/2026, attached.

This behavior has been an ongoing issue in the town, and seemingly without any legal recourse, until now. Hopefully, such an admission on camera by Selectman Dubreuil, coupled with the attached documentation as even more damning/supporting evidence, including a potential violation of RSA 637:3, Theft by Unauthorized Taking, should warrant the opening of an investigation by those legal entities tasked with law enforcement, YOU!

Apparently, thousands of taxpayer dollars have been spent without legal Selectboard knowledge/authorization, as evidenced in the attached documentation. This has been an ongoing issue, with very recent, public admissions and behaviors by these two elected officials. Also see January 16, 2025 Special Meeting minutes, as this behavior(s) was specifically addressed by the Town of Dalton legislative body last year.

The HCA Committee was formed specifically to negotiate on behalf of the Town of Dalton, to prevent this very behavior of the two Selectmen, from occurring. See attached January 16, 2025 Special Town Meeting minutes and February 2, 2026 HCA meeting minutes, where the two elected officials fail in their attempt to circumvent the will of the town legislative body and the HCA Committee, in order to facilitate local approval of the HCA legal agreement. It is blatantly obvious that these two men have been conspiring in illegal, non-public meetings, leading up to the attempted override of the legal authority of the HCA Committee, including seeking legal counsel, unauthorized yet at taxpayer expense.

Selectman Dubreuil's ongoing, problematic, and now obviously/admittedly illegal behaviors were specifically addressed in that Special Town Meeting. One year later, and the behavior has not changed, but now with a confession on video. Selectman Dubreuil can no longer feign ignorance of the law, as has been his MO. He didn't stop talking on video quite quick enough.

I have contacted your offices previously in the past, so the dots continue to connect. I hope someone will look into this behavior, as I am of the firm opinion that it is illegal. There is a lot of money at play with the GSL project, if it were to ever come to fruition, and Dalton would be home to decades of out-of-state trash trucked in by Casella. What these two elected officials have been doing outside of public meetings in order to facilitate this landfill project needs to be investigated. Where there's smoke...there would appear to be a conspiracy perpetrated by two elected officials in Dalton, NH for the benefit of an out-of-state waste company and its controversial landfill project.

We are a nation of laws, right?
