STATEMENT OF FACTS IN SUPPORT OF MOTION FOR SUMMARY JUDGMENT

Petitioner, Granite State Landfill, LLC, ("GSL"), by and through its attorneys, Cleveland, Waters and Bass, P.A., and hereby submits the within statement of material facts in support of Casella's motion for partial summary judgment; and the Defendant, Jon Swan, and submits his responses creating disputes of material fact.

- 1. On October 31, 2023, GSL submitted an application to the State of New Hampshire Department of Environmental Services ("NHDES") for a standard permit for the development of a municipal solid waste landfill in Dalton, New Hampshire (the "Application"). Affidavit of Melissa Stevens ("Stevens Aff."), at ¶4, attached hereto as Exhibit 1.
- 2. On February 28, 2024, NHDES issued a letter advising GSL that it deemed the Application incomplete and requesting additional documentation to complete the Application. Stevens Aff. at ¶5.
- 3. GSL submitted its response to that letter, including additional documentation, on April 19, 2024, April 22, 2024, and June 17, 2024. Stevens Aff. at ¶6-8.
- 4. NHDES issued a second letter advising GSL that it deemed the application incomplete on June 24, 2024. Stevens Aff. at ¶9.

- 5. GSL submitted additional documentation in response, which consisted of an additional submission of 174 pages. Stevens Aff. at ¶10.
- 6. NHDES issued a third letter deeming the application incomplete on October 22, 2024. Stevens Aff. at ¶11.
- 7. In response to that third letter, GSL made an additional submission of 98 pages. Stevens Aff. at ¶12.
- 8. On January 27, 2025, NHDES issued a fourth letter deeming the application incomplete. Stevens Aff. at ¶13.
- 9. This letter raised several new issues based on changes to NHDES's rules which went into effect while NHDES was assessing the application for completeness. Stevens Aff. at ¶14.
- 10. In response to the fourth letter, GSL made another submission on February 27, 2025 which compromised over 300 pages. Stevens Aff. at ¶15.
- 11. NHDES then determined that that GSL was still incomplete and denied it based solely on the claim that it was a dormant application under N.H. Code Admin. R. Env-Sw 304.06(d) and Env-Sw 305.03(b)(6). Stevens Aff. at ¶16.
- 12. NHDES has never applied these dormancy provisions against an applicant who submitted any response to an incompleteness determination. *See* Exhibits 2-8 (dormancy denials from NHDES).
- 13. NHDES has only applied these dormancy provisions against applicants who failed to submit any documentation in response to an incompleteness determination from NHDES. *See* Exhibit 2 (dormancy denials from NHDES).

AFFIDAVIT OF MELISSA STEVENS

- 1. My name is Melissa Stevens.
- 2. I am the Associate General Counsel of Granite State Landfill, LLC ("GSL").
- 3. As part of my responsibilities, I have been involved in the application process for GSL's proposed landfill in Dalton, New Hampshire.
- 4. On October 31, 2023, GSL submitted to NHDES an application for a standard permit for the development of a municipal solid waste landfill in Dalton, New Hampshire (the "application").
- 5. On February 28, 2024, NHDES issued a letter advising GSL that it deemed the Application incomplete and requesting additional documentation to complete the Application.
- 6. In response to the February 28, 2024, letter, GSL submitted additional documentation on April 19, 2024, April 22, 2024, and June 17, 2024.
- 7. The April 19, 2024 submission consisted of a cover letter to NHDES which provided substantive responses to each of the 16 comments and sub-comments, and attached 12 exhibits totaling more than 900 pages.

- 8. As part of the April 19, 2024, submission, GSL was required to conduct additional analyses, provide further supporting calculations, and other supporting documentation as outlined in the cover letter to this submission.
- 9. NHDES issued a second letter advising that it deemed the application incomplete on June 24, 2024.
- 10. In response to the second letter, GSL made an additional submission of 174 pages.
- 11. NHDES issued a third letter deeming the application incomplete on October 22, 2024.
 - 12. In response to the third letter, GSL made an additional submission of 98 pages.
- 13. On January 27, 2025, NHDES issued a fourth letter deeming the application incomplete.
- 14. This letter raised several new issues based on changes to NHDES's rules which went into effect while NHDES was assessing the application for completeness.
- 15. In response to the fourth letter GSL made another submission on February 27, 2025, which comprised over 300 pages.
- 16. Despite these submissions, and despite lacking any legislative authority, on April 3, 2025, NHDES denied GSL's application on the ground that it was dormant pursuant to N.H. Code Admin. R. Env-Sw 304.06(d) and Env-Sw 305.03(b)(6)
