Studio Policy 2025/2026

Thank you for selecting Studio 150 as your dance studio. We are confident that you will be satisfied with the quality of dance training at this studio. We look forward to many years of dance training to come.

Here are a few items which you need to know. Please read this policy carefully and feel free to ask questions.

REGISTRATION:

There is a \$75.00 registration fee. This non-refundable fee is due upon registration. The first month's tuition is also due upon registration, this is also non-refundable.

TUITION:

Tuition is based on a yearly fee. For your convenience it can be paid in 9 equal installments. Tuition is collected monthly and is due by the first lesson of each month. Anyone wishing to pay tuition in advance may do so. Once tuition is paid, it is non-refundable. There will be a \$10.00 late fee added to all accounts not paid by the 10TH of each month; regardless of the day the 10th falls on. THERE WILL BE A \$35 SERVICE CHARGE ON ALL CHECKS RETURNED BY THE BANK.

ATTIRE:

Students are required to come to class in proper dance attire, (please see dress code policy). Absolutely NO GUM or food will be allowed in class. For safety reasons, students without proper attire and footwear will not be allowed to participate in class.

ATTENDANCE:

Students are expected to attend all regularly scheduled lessons. If a student misses a lesson, they may make it up during another regularly scheduled class of the same or lower level. There are no refunds for missed classes. You must call in advance for makeup lessons.

CANCELED CLASSES:

When lessons need to be canceled due to adverse weather conditions, an email message will be sent, and will also be posted on our website. Lessons will be canceled very infrequently; however, if you are in doubt, please call or check our website. Arrangements will be made for students to make up the canceled lesson. ANNUAL DANCE CONCERTS:

Our Nutcracker Performance will be December 12, 2025.

A spring dance concert starring our students will be planned for May 8, 2026. To participate, the students must meet the following requirements:

1. Have good attendance throughout the year. No more than 8 lessons missed.
2. Have perfect attendance in the months of showcase (some exceptions will be made with teacher's consent).
3. Purchase a costume for each subject that she/he wishes to participate in. (Nutcracker are rented costumes not purchased)
4. Have all tuition, late fees and costume fees paid in full.
5. Attend dress rehearsal (NO EXCEPTIONS).

Tickets for the recital will be sold during the month of showcase. Tuition and late fees must be paid in full before you can purchase tickets or participate in the recital.

COSTUMES:

The costume for the spring showcase is paid in full and is due by January 15th. Costumes will not be ordered unless paid in full by the due date. All costume payments are non-refundable.

HOLIDAYS: We will be closed to observe the following holidays:

December 22 – January 2. Classes resume Monday January 5, 2026. Christmas Break

March 16 – 20. Classes resume Monday March 23, 2026. Spring Break

April 5 - Day after Easter campus is closed

As with any physical activity, injuries may occur. Dancing when taught correctly and carefully, will reduce the risk of injury. To reduce the risk of injury I will provide my child or myself with the proper dance attire and shoes required for each class. For the safety of my dancer or myself, I understand that after the first 15 minutes of class, I or my dancer may have to watch and not participate in class after the warm up is over.
