The Lassen County Sheriff's **CrimeGraphics.com** "Media Bulletin" was never meant to be an honest account, to the public, of crime in Lassen County, just a deception.

CLCSOC now has copies of the "Media Bulletin" from July 3, 2024 and **will continue to monitor this data.**

Public documents show that Morris and Johnson had been previously detained by Butte County for drugs.

Anna Kiplinger climbed over the 602 Ash fence with a 4' board and made threats of great bodily harm to the owner of 602 Ash Street, Westwood. The Owner sprayed the trespasser with a garden hose.

Deputy Falchetta has defended Anna Kiplinger for many crimes over the past two years. It was revealed, in Deputy Falchetta's body cam, that he was hired to protect the illegal activity for the residences of 600B Ash Street, Westwood.

Evidence confirmed that Deputy Falchetta coerced false testimony from Anna Kiplinger, Taylor Wiedeman and Joann Peck. Deputy Falchetta failed to secure evidence, at the scene, of the trespass and assault by Anna Kiplinger.

The District Attorney failed for nine (9) months to review the case. The case was scheduled twice to go to trial. Deputy Falchetta failed to attend the hearing for the trial scheduled on 1/3/24. The second trial date was set for 4/4/24. The District Attorney dismissed charges for "insufficient evidence" on 3/22/24 without informing the Defendant.

The District Attorney failed to bring charges against Deputy Falchetta, Anna Kiplinger, Tyler Wiedeman or Joann Peck for perjury. An official documented complaint (700 pages) was filed against Deputy Falchetta.

TAB 1-SERIOUS OFFENCES -CLOSED W/ NO ACTION TAKEN

Serious offences are reported as “DISPOSITION: CLOSED OTHERWISE NO FURTHER ACTION IS REQUIRED”. The chart shows that these crimes include rape, burglary, fraud, theft, child abuse, battery, firearms, drugs and weapons to name a few.

TAB 2-Discrepancies in “CALL” traffic

CLCSOC monitored the “call” traffic from 7/3/24. The data will show the amount of calls in a 24 hour period and the average call per hour.

Dispatch actual statistics indicate that between a low of 36 calls in a 24 hour period (an average of 1.50 calls per hour) and a high of 102 calls in a 24 hour period (an average of 4.25 calls per hour) are received. The Sheriff’s Budget reflects 8 FTE.

TAB 3- December 2024 “Bulletin” Arrests/Incarceration Reports

Attached is a copy of the “Media Bulletin” report from December 22, 2024 to December 29, 2024. The Arrest-in-custody posts should match the Incarceration posts but show constant discrepancies.

“Media Bulletin” report dated 12/22/24 to 12/29/24 includes:

632 calls received 221 calls reported 411 calls deleted

NOTE: Between 56% and 65% of the crime statistics in the “MEDIA BULLETIN” are omitted each week.

TAB 4 Arrests and Incarcerations

Crime Graphics.com allegedly was to represent the actual ARRESTS and INCARCERATIONS in Lassen County to the public. ***Actuals, for the most part, have been deleted.***

The arrests/incarcerations in the CLLCSOC database, depicts records compiled from Court records, Arrest Reports, Incarceration reports and the abbreviated information reported by the "Media Bulletin".

In order to retrieve the deleted records, a search of Court Records was needed. However, Court records of certain names were blocked. This report identifies discrepancies between what CrimeGraphics.com reported and the actual arrests. ["arrest- in-custody" statistics don't match the "incarcerated" statistics]

TAB 5- Examples of gross misuse of authority

The CrimeGraphics.com website, (which contains intentional discrepancies & misleading entries, and tampered Court records) suppresses accurate arrests and incarceration data.

Sheriff Policies & Procedures

Disclosable Public Reports:

Incident/Criminal reports are disclosable to the public. Copies of the Deputy's written reports, witness statements, victim statements, can be requested under the Public Records Act and mandates the Sheriff's Department to respond within ten (10) days.

The Sheriff cannot refuse to release these public documents. The Public has a right to information about a specific public action by the Sheriff. The Deputy responding can/and should give you the Incident Number or the public can call 257-6121 and give the DATE, TIME of the incident and the Report number can be released.

The Sheriff assigns a number to Incident Reports (example: 2412310001) The year, month, day and numbers for each dispatched incident (in chronological order).

The Sheriff assigns a Case Number. The Case Number is an eight (8) digit number that will appear on the Incident Report (example: 24-01-0001)

1. Disclosure of Incident numbers

Responding Deputies are assigned Incident numbers as they are dispatched to a call. The Deputy responding has this case number and must disclose it to the victim or suspect.

2. Intimidation by a Deputy/Deputies of witnesses and victims is prohibited and should be documented and reported. Video, witness statements and photographs are "evidence".

3 Victims have a right to submit a "Victim Statement", of their Incident in writing, to the Sheriff. The Sheriff also has a form available and the victim can attach their written statement to this form.

4. Authorizing false reports is a crime. Authorizing the contents of arrest reports to be altered or deleted is a crime.

5. Allowing a Deputy or Sheriffs staff to make intentional false statements in a public record that benefits a personal motive is a crime.
