#### • Director Liability Insurance (Flynn)

Board agrees to review current Director and Officer Liability Insurance provider prior to next annual premium payment to determine if a less expensive option is available.

- \*\* Morahan to send copy of current insurance policy to Board Members.

## • Beetle-kill trees (Flynn)

There are indications that some lots within our HOA may be infected with Pine Beetle, Budworm and/or Mistletoe in both felled and standing trees.

Recommended tree service companies include Fisher Tree Care (recommended by Beckhorn).

- \*\* Flynn to arrange for meeting with Forest Service about options for identifying and mitigating damage done by these trees.
- \*\* Flynn to get three (if possible) estimates to mitigate damage.
- \*\* Fynn to write draft notification letter to affected lot owners pursuant to Article II, Section 7 (Diseased Trees) in our CCRs.
- \*\* Morahan to speak to Jim Yarnold (webmaster) to see if Woodside HOA (Units 5&6) maps are available on the website.
- \*\* Windemuller to ask Ranch staff if they intend to spray for tree pests in the near future.
