

Swimming Pool Rules and Regulations **of the** **Rivershire Bath and Tennis Club Association**

The swimming pool will be open from Memorial Day to September with specific dates determined each year by the Board of Directors. The pool is open daily from 7:00 AM to 8:00 PM. Any person accessing the pool facility when it is closed will be considered a trespasser.

The following Rules and Regulations are for the benefit of all residents and persons using the pool and pool facility to insure its safe and sanitary operation. Your cooperation in abiding by these Rules and Regulations will afford all residents the ability to enjoy the pool facility. When using the pool facility, all owners, tenants, and guests, acknowledge and recognize that they are swimming at their own risk and agree that Rivershire Bath and Tennis Club Association (the "Association"), its owners, agents, and employees or assigns, shall not be liable for any damages arising from personal injury sustained by any owner, tenant, or guest of said owner/tenant, as a result of the use of the swimming pool. In addition, the Association, its owners, agents and employees or assigns shall not be liable for any loss or theft of personal property occurring in or about the pool facility. All persons using the pool facility fully and forever discharge the Association, its owners, agents, and employees or assigns from any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same is known or unknown, anticipated or unanticipated, resulting from or arising out of the use of the swimming pool and pool facility. The Association intends on enforcing all Rules and Regulations, along with any and all other regulations set out by the State of Illinois.

Any person may be barred from the swimming pool and/or pool facility for violation of any of these rules and regulations.

Private functions are not permitted at the pool facility except when the Association has reserved the pool facility for the purpose of hosting an annual social event for members of the Association.

Rules and Regulations

STATE OF ILLINOIS REGULATIONS

The following are mandatory State of Illinois swimming pool regulations in accordance with Section 820.360 of the Illinois Swimming Facility Code (revised 2013):

1. Admission to the swimming facility shall be refused to all persons having any contagious disease, infectious conditions such as colds, fever, ringworm, foot infections, skin lesions, carbuncles, boils, diarrhea, vomiting, inflamed eyes, ear discharges, or any other condition that has the appearance of being infectious. Persons with excessive sunburn, abrasions that have not healed, corn plasters, bunion pads, adhesive tape, rubber bandages, or other bandages of any kind shall also be refused admittance. A person under the influence of alcohol or exhibiting erratic behavior shall not be permitted in the swimming facility.
2. The pool water is not suitable for drinking. Patrons should avoid swallowing pool water.
3. Littering is prohibited. No food, drink, gum or tobacco is allowed in other than specially designated and controlled sections of the swimming facility. Glass containers are prohibited.
4. No one should swim alone.
5. Personal conduct within the swimming facility shall not jeopardize the safety of self and others. No running or boisterous or rough play, except supervised water sports, is permitted.
6. Persons less than 18 years of age must be accompanied by a responsible person 18 years of age or older unless a lifeguard is present.
7. Spitting, spouting of water, blowing the nose or otherwise introducing contaminants into the swimming facility is not permitted.
8. Glass, soap or other material that might create hazardous conditions or interfere with efficient operation of the swimming facility shall not be permitted in the swimming facility or on the deck.
9. If present, lifeguards are responsible for enforcing safety rules and responding to emergencies. Parents or guardians should supervise their children.
10. All children who are not toilet-trained shall wear tightly fitting disposable swim diapers.
11. Diving is not permitted.
12. Caution shall be exercised in the use of diving facilities.
13. Swimming is prohibited at outdoor swimming facilities when thunder is heard or lightning is seen, including a 15-minute period after the last lightning or thunder is detected.
14. All persons are encouraged to take a shower before swimming.

15. Only clean footwear, baby strollers or wheelchairs are allowed in the swimming facility.

16. All apparel worn in the swimming facility shall be clean.

ADDITIONAL POOL RULES

The pool and deck are open to all RBTA members. Private functions are not permitted; the exception being when a Homeowner Association or Condo Association has reserved the pool and deck for an annual get-together.

1. All guests must be accompanied by a member of the Association 18 years or older at all times, including leaving when the member of the Association leaves. A member (defined as a household and not an individual) may have no more than 8 guests at the pool facility at any one time. Members of the Association are strictly prohibited from "loaning out" their pool fobs.
2. All persons under the age of 18 must be accompanied by a supervising adult. If the supervising adult leaves the pool area, the individual under the age of 18 must also leave the pool area. An adult is defined as an individual 21 years of age or older.
3. All persons must shower before entering the swimming pool.
4. No more than 40 people are permitted in the swimming pool at any one time.
5. No smoking, vaping or e-cigarettes are permitted anywhere in the pool facility, including but not limited to the swimming pool, the decks, washrooms, and areas just outside the fencing of the pool facility.
6. No food or drinks are permitted in the swimming pool. Food and non-alcoholic drinks are permitted in the deck area.
7. If a member, tenant of a member, or a guest causes any damage, either intentionally or unintentionally, to the swimming pool which requires the swimming pool to be chemically cleansed (referred to as "shocked"), a fine in the amount of \$200.00 (the cost of chemicals and the pool service company's labor) will be assessed to the member. If said damage requires emptying and refilling the pool, the member will be fine the sum of \$5,500.00 (the cost of water, chemicals and the pool service company's labor).
8. All individuals must use their best efforts to maintain the cleanliness of the bathrooms upon using same.
9. Running, diving and cannonballs into the pool are strictly prohibited
10. Pets are not permitted in the pool area.
11. No glass containers are permitted in the pool facility. Only plastic, steel or aluminum water bottles are permitted.
12. Any umbrellas used must be closed and tied-up upon leaving the pool facility.

13. Any chairs, tables, and/or other furniture used in the pool facility must be cleaned and returned to its proper location upon leaving the pool facility.
14. Use of electronic devices such as radios and speakers must be restricted to low volume levels and used for personal enjoyment only; otherwise, you will be asked to turn off said radio or speaker; failure to do so will result in being asked to leave the pool area.
15. Unlocking the gate to the pool facility for others is strictly prohibited.
16. The pool facility may be closed at any time, without notice, due to inclement weather, breakdown of equipment or other operational difficulties, routine maintenance, or for any other emergency situation.
17. All garbage must be properly placed in garbage cans.
18. Running is strictly prohibited anywhere within the pool facility.
19. Sitting on the fence or climbing on the fence surrounding the pool facility is strictly prohibited.
20. Fishing from the deck into the pond is strictly prohibited.
21. Throwing food or garbage into the pond is strictly prohibited.

RBTA POLICY FOR 2025 SUMMER MEMBERS

The Board of Directors of Rivershire Bath and Tennis Association (RBTA) adopts the following policy regarding elective members.

All members of RBTA, including elective members, shall be responsible for paying the full annual assessment (\$850 for the calendar year 2025). At present, there is no initiation fee for new elective members. There are also no seasonal partial memberships. Annual assessments will only be prorated based on the date of membership, and not use of facilities. We ask everyone to recognize that RBTA's budget is based on a full year of expenses and cannot be adjusted based on a member's use of the pool or courts.

Residents of the 100/ 203/205/207 buildings who choose not to join as an elective member will not be allowed into the pool or deck areas as guests.
