T.C.A. 30-4-101 et seq.

Small Estate Limited Letters of Administration are used to administer a small estate left by the decedent. "Small Estate" means the probate estate of the decedent in which the value of the probate property does not exceed fifty thousand dollars (\$50,000.00).

FILING FEE:

Without Will - \$100.50

With Will (Lodged for Safekeeping)- \$105.50

FORMS REQUIRED:

Petition and Order for Small Estate Limited Letters of Administration

Waiver of Bond (1 for each next-of-kin heir of Deceased)

Original Will

Certified Copy of Death Certificate - Original (No copy will be accepted)

The total value of all the personal property must be \$50,000.00 or less. (Real property not included)

The decedent must have <u>resided</u> in Johnson County. If the decedent's place of death was in the County but the decedent's residence was in another county, the Petition must be filed in the county of residence, <u>NOT</u> this County.

You must wait forty-five (45) days from the date of death to file the Petition.

You must include the decedent's full name (as it appears on the Death Certificate) when preparing the Petition.

As the Petitioner, you must obtain <u>signed and notarized</u> Waivers of Bond forms from all the next-of-kin heirs. <u>Note:</u> Minor and incompetent individuals cannot consent.

If the Petition incorporates minors or incompetents, the Court may set a Bond for the value of the personal property sought in the Petition. (Please seek legal advice from an attorney)

You must list any known unpaid debts the decedent had at the time of death. Please list the creditor's name, address and amount of the debt. If the amount of the debt exceeds the value of the personal property, you should seek legal advice from an attorney.

If you paid for the funeral expenses, you may list yourself as a creditor in order to be reimbursed for that expense. (Please attach receipts for funeral expenses to the Petition)

List the location and value of the property you are trying to gain access to.

Complete the Petition and bring it with you to the Chancery Court/Probate Division along with the other required documents.

An appointment must be made with the Clerk and Master before the filing of the Petition.
