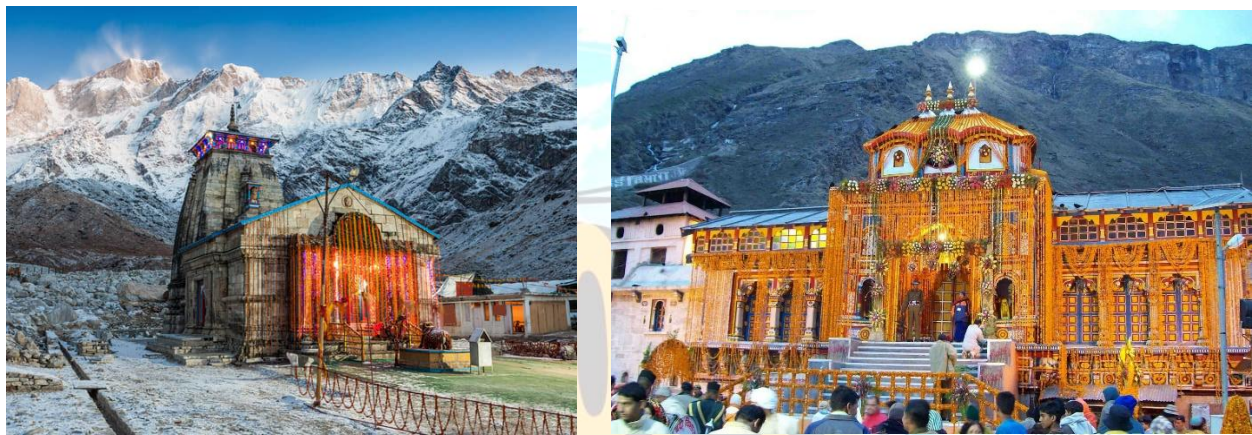




Do Dham Yatra by Helicopter : Same Day



Destination : Dehradun - Kedarnath - Badrinath – Dehradun

Yatra starts from the capital of Uttarakhand the queen of the hills... Dehradun. Dodham Yatra by helicopter (Badrinath & Kedarnath) offers you a chance to pay homage to your lords and enjoy some refreshing moments nestled in the lap of nature. Badrinath is known as the abode of Lord Vishnu (Badri) and Kedarnath is a shrine dedicated to Lord Shiva.

Morning take off from Sahastradhara heliport in Dehradun by 06:30am / 10:15 am to Phata/ Sersi helipads. Due to Government regulations guests are to be shifted to shuttle helicopter from same helipad to fly to Kedarnath. Upon arrival at Kedarnath helipad walk till Mandir which is about 300 mts from helipad.

VIP darshan slips at the temple are arranged for you to have a special puja. Post Darshan fly to Phata/Sirsi & fly to Badrinath by 09:30 am /1130 AM.

Upon arrival at Badrinath helipad transfer to the temple by Car for VIP Darshan & Post Darshan you are transferred to the helipad to commence return journey to Dehradun by 11:55 PM /3 PM.....end of Holy Yatra upon arrival at Dehradun heliport.

TERMS & CONDITIONS

- Flying is subject to Full Load in Helicopter i.e. 5/6 Person on seat basis flying.
- Covid-19 Guidelines will be applicable as per the Government of Uttarakhand.
- Flying in hills are subject to many factors like delayed clearances from Air Force & Civil Aviation, VVIP movements, valley flying by Indian Air Force (NOTAM), bad weather, sudden occurrence of technical snag in helicopter, illness of flying crew or late reporting of the guests at the helipads it may be plus minus 2 hours .
- Any passenger weighing above 75 Kg, shall have to pay extra weight charges @ INR 1500/kg for the excess weight, toward the extra weight charges shuttle service at Sersi on direct payment basis.
- Our company shall not be liable for any medical emergency on the ground to the party. Therefore, in your own interest, guests are hereby advised to kindly consult a doctor and

get medical check-up done, before commencing the yatra. Medical check-up is mainly required if a guest has any medical suffering/condition.

- Any donations, tips, pitthu and porter charges shall be borne by the guests only.

CARRIAGE BY AIR ACT, 1972

The liability of the company for damage sustained in the event of the death or wounding of a passenger or any other bodily injury suffered by passenger or by his registered baggage during the course of carriage by air will be governed by the provisions of sections 4,5,6 and the rules contained in the second Schedule of Carriage by Air Act 1972 with certain exceptions, adaptations, modifications, etc as notified in the Govt. of India, Ministry of Civil Aviation Notification and as amended from time to time.

- **BOOKING FORWARDING:** Sometimes as tour operator we are working as forwarding agents to other operator due to non availability of aircraft , Weight Issue , Technical issue in aircraft and some commercial calls of the company but on that case our company representee will assist you and take all your follow ups for smooth yatra operations .
- **INFANTS** Infant below 2 years/12kg are carried free of charge. In case of verification of age, ID proof/birth certificate of the child shall be checked.
- **HAND BAGGAGE ALLOWANCE** Only one handbag weighing a maximum of 5 kgs is allowed per passenger.

- **HELICOPTER WEIGHT LIMITATION**

Passengers would be taken on board depending up on the load and temperature conditions. Pilots call will be final. **Maximum weight capacity of the helicopter is 450 kg (excluding baggage weight)** at these destinations. All passengers on board must be within this limit. Hence, passengers are advised to provide us their exact weights at the time of booking and carry baggage within the permissible limit. If weight shared with us is incorrect at the time of boarding Passengers will be deboarded without any refund .

- **DISPUTES** Disputes as to legality, interpretation, application or performance of service or any of its terms and conditions shall be governed by the laws of Uttarakhand Jurisdiction.
- **PAYMENT TERMS**

The booking has to be done in advance with a deposit of 50% of the charter amount. Full amount has to be deposited 7 days prior to date of journey. Rescheduling of booking to a next date will be done subject to availability and on payment of 10% of the cost. This will be permitted only if informed 10 days before arrival date. In case the rescheduling is requested with less than 10 days to the arrival, then the booking would be treated as cancelled and a fresh booking will be given subject to availability.

CANCELLATION/REFUND POLICY:

If passengers wish to cancel their booking then they will have to pay following cancellation charges -

More than 15 days before the departure date — 30% of total charter amount

- Between 08th to 15th day before departure date — 50% of total charter amount
- Up to 07th day before the departure date — No Refund.
- No show – No Refund.
- Kindly Keep One Day In Hand : If any of one dham completed and one dham schedule to next day (It may be subject to backlog and availability) due to weather or any administration reason , VVIP Flying ,NOTAM & Local Protest/Strike at the base location of dham which is beyond our control there may be possibility of night halt over their on direct payment basis and if passenger wish to cancel his journey due to his personal issues and plan to come back to dehradun then their will be no refund .
- Bad weather or Lockdown due any national and international emergency – Full refund toward the proportionate amount of the Unutilized sector(s)/Flying , minus INR 20,000 toward the flight preparation and ground arrangement charges.

Bookings will be accepted, only on acceptance of the above-mentioned terms and conditions by the guests. In case of bookings through a tour operator/travel agent, the same shall be applicable.
