# Instructions to apply/renew for a lead certification

### Link to log into the portal

#### Click Sign In

If you do not know your password, you can use the forgot password link at the top of the page. For password assistance, contact OCIO at 800-532-1174

Click **Apply for a Program** or click **renew** if completing a renewal (skip to answer the questions)

Select Program as **Lead Professionals**.

Select Program Detail as the correct lead discipline course you completed. (ie: EBL Lead Inspector/Risk Assessor, Lead Abatement Contractor, Lead Abatement Worker, Lead Inspector/Risk Assessor, Lead Safe Renovator, Project Designer, Sampling Technician)

#### Click Continue.

Click **OK** on the pop-up window.

Answer the questions under affirmation, lead safe renovator infos, additional information, reciprocity \*\*if you have taken an Iowa course: answer NO to the Reciprocity and Reciprocal questions. (only answer YES if you are applying with a course from another state)

Click **Certified Firms** under the application form details section (for renewal if you get an error message uncheck the IA certified/licensed box)

Click **Add**, complete each column (use the scroll bar to see any hidden columns to the right). You are NOT certified yet. Please DO NOT enter your course certificate # as your lead certification #.

### Click Save

Click **Reciprocity Certification** to be completed ONLY if you are applying with an out of state course.

#### Click Continue

Click **OK** on the pop-up window.

Click **Expand All** on the right side of the process free form description section and complete the necessary sections for your discipline.

EBL Lead Inspector/Risk Assessor - Lead Inspector/Risk Assessor - Sampling Technician - Lead
Abatement Contractor - must complete Education - attach Form A, Third Party Testing
(Contractor/Inspectors Only) - attach a statement from the EPA or from the state showing you passed with 80% or above score, Experience - attach Form B, XRF Training (Inspectors only) - attach XRF Certificate, Reciprocal Certification Exam (Reciprocal Contractor/Inspectors Only) complete only if you are applying with an out of state course - attach Proctor Form

Lead Safe Renovator - Lead Abatement Worker - must complete **Lead Terms and Conditions** ONLY if applying with an out of state course (Renovators will attach Form C, Workers will attach Form D)

Click **Add New Attachment** – see above for needed attachments for each discipline – attach a copy of your course certificate, attach documentation for any YES affirmation question answer(s), Reciprocal Applicants – must also attach proof of their certification in another state or with the EPA. They will also need to have their training provider email (<a href="mailto:lead.bureau@idph.iowa.gov">lead.bureau@idph.iowa.gov</a>) a statement with their lead course test score and jpg electronic photo file.
