

Gary initiated North Vancouver's Truth & Reconciliation efforts including a city contribution to the St. Paul's Residential School memorial and authoring a report on a civic response to the report on Missing & Murdered Indigenous Women and Girls. He has worked extensively with developers, non-profit groups and the community to achieve successful results.

Gary is an expert in the municipal development process and was a consultant to the BC Government on the Development Approval Process Review (DAPR).
