The customer further agrees to pay all collection costs, including reasonable attorney fees, incurred in the collection of any unpaid amounts or resulting from litigation or other dispute resolution procedure related to transactions arising pursuant to this agreement. The customer agrees that the sales and transactions between the parties shall be governed by the State of Oregon. The customer further agrees that any litigation or other dispute resolution relative to transactions or amounts due by the customer shall be venued in Multnomah County. Customer agrees to pay \$50 fee for a returned check.

I agree to indemnify, hold harmless and defend JW Underground Enterprises, Inc, its successors, or assigns from any and all causes of action of any kind arising out of the actions or omissions of the customer, including the acts and omissions of the customers employees, officers, directors, subsidiaries, affiliates, partners, owners, subcontractors, successors, assigns and agents. The customer further agrees that JW Underground Enterprises, Inc is not obligated to indemnify the customer, including customer employees, officers, directors, subsidiaries, affiliates, partners, owners, subcontractors, successors, assigns and agents, for any action or omission of customer or otherwise.
