President Jimmy Carter - Founding member of TLC

Instituted the

The Refugee Act of 1980: Signed into law to systematically manage refugee resettlement, it significantly aided international family reunification by letting families bring separated relatives safely into the United States

White House Conference on Families (1980): Carter initiated this nationwide conference to address the economic and social pressures facing modern American households, dealing with topics like day care, tax policies, and the changing definition of family.

Child Welfare and Education: His administration expanded federal funding for child welfare, daycare programs, and low-income student aid through the creation of the federal Department of Education

George H.W. Bush served the TLC in the late 70's before he became Vice President then President and created

Family Fairness Immigration Policy: Continuing an initiative from the Reagan administration, the Bush administration used executive authority to protect roughly 1.5 million undocumented spouses and children of individuals who had qualified for legal status under the 1986 immigration reform from being deported.

Welfare and State Waivers: In his 1992 State of the Union address, Bush promoted shifting away from traditional federal welfare paradigms by encouraging and fast-tracking federal waivers for states experimenting with local welfare-to-work and Aid to Families with Dependent Children (AFDC) reforms.

Bill and Hillary Clinton Joined the group prior to his election to the presidency in 1992.

Bill Clinton through Alan Greenspan then had the United States federal reserve join the Bank of International Settlements in 1994 in violation of

the U.S. Constitution

Welfare Reform (PRWORA): Signed the Personal Responsibility and Work Opportunity Reconciliation Act in 1996, replacing Aid to Families with Dependent Children with state block grants and adding work requirements.

Created the Violence Against Women Act (VAWA): Signed into law to protect family members and individuals from domestic violence and abuse which is a major pipeline of federal grant fraud to state nonprofit organizations.

In 2009, Secretary of State Hillary Clinton helped negotiate a "sweetheart" compromise with Switzerland's UBS bank to settle a major IRS tax evasion lawsuit against UBS AG, allowing the bank to turn over data on 4,450 secret accounts instead of the 52,000 originally demanded. After which UBS donated more than 1.5 million in "speaking fees" and UBS partnered with the Clinton foundation on small-business loan and entrepreneurship programs, providing \$32 million in loans to the Clinton Global Initiative
