Royal Treasury Decree

Lawful Notice Regarding the Hawaiian Kingdom Treasury

I, Mana Ali'i Nui Aleka Aipoalani, Supreme Sovereign Authority of the Polynesian Kingdom of Atooi / Hawaiian Kingdom, mindful of the duty to safeguard the welfare of Our people, lands, and future generations, do hereby proclaim the following:

Whereas, The Hawaiian Kingdom has always remained a sovereign, independent State, recognized by the family of nations through treaties, including the Treaty of Friendship, Commerce, and Navigation of 1849 with the United States of America, and the Anglo-French Proclamation of 1843.

Whereas, The Hawaiian Kingdom lawfully exercised financial sovereignty through its Treasury, issuing Treasury Notes, Silver Certificates, and Gold Certificates, all backed by reserves of silver and gold deposited under the authority of the Minister of Finance.

Whereas, the unlawful overthrow of 1893 and the purported annexation of 1898 did not extinguish the Hawaiian Kingdom, nor its lawful rights to its Treasury and financial assets, which remain protected under the doctrines of continuity of states, *pacta sunt servanda*, postliminium, and trusteeship under occupation law.

Whereas, to secure the prosperity of the Nation and reaffirm the Kingdom's financial sovereignty, it is necessary to reconstitute the Treasury of the Hawaiian Kingdom.

Therefore, As the Supreme Sovereign Authority of the Polynesian Kingdom of Atooi / Hawaiian Kingdom, be it known to all living souls hearing or seeing this lawful Decree:

Article I — Reconstitution of the Treasury

The Treasury of the Hawaiian Kingdom is hereby formally reconstituted under the authority of His Majesty Mana Ali'i Nui Aleka Aipoalani, to act as the lawful repository and issuing authority of the Kingdom's financial system.

Article II — Minister of Finance

The Minister of Finance is hereby empowered and directed to:

1. Establish and manage the accounts of the Treasury, both domestically and internationally.
2. Receive, secure, and account for all revenues, duties, fines, fees, and other monies due to the Hawaiian Kingdom.
3. Issue, under Royal authority, Treasury Certificates, Bonds, and such lawful instruments of exchange, whether in paper or digital form (including the Kala currency), backed by the credit, assets, and resources of the Hawaiian Kingdom.
4. Audit, recover, and reclaim assets of the Kingdom held unlawfully by foreign governments, institutions, or banks, in accordance with international law.

Article III — Auditor and Oversight

A Royal Auditor shall be appointed to independently verify, safeguard, and report on the accounts of the Treasury to the Crown and Privy Council, ensuring transparency and righteousness in all dealings.

Article IV — International Notice

This Decree shall be transmitted to all treaty partners, states, and financial institutions, including the United Nations, notifying them of the reconstitution of the Hawaiian Kingdom Treasury and the resumption of all financial functions by the lawful government.
