VERFID LLC Terms of Use

The website located at https://verfidaccount.com/ (the "Website") and our mobile application (the "Mobile App," together with the Website, "VERFID Technology") are published, owned, and operated by VERFID, LLC, its affiliates and related entities ("Company," "we," "us," and "our"). These Terms of Use (the "Terms") govern your access to and use of the VERFID Technology.

By accessing, browsing, submitting information to and/or using the VERFID Technology, you agree and acknowledge on your own behalf (referred to throughout the Terms as "you") that you have read, understand and agree to be bound by these Terms and to comply with all applicable laws including, without limitation, all federal, state and local tax and tariff laws, regulations, and/or directives. If you do not agree to the Terms, please do not use the VERFID Technology.

<u>Purpose of the VERFID Technology</u>. The VERFID Technology is provided solely for informational purposes and the purposes of enabling communication between you and the Company.
