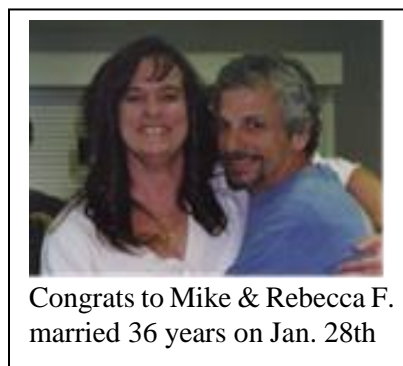
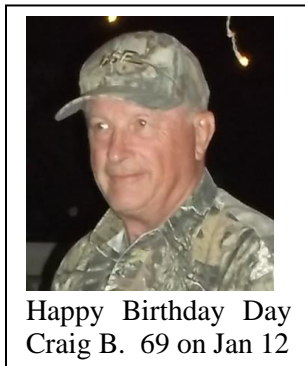
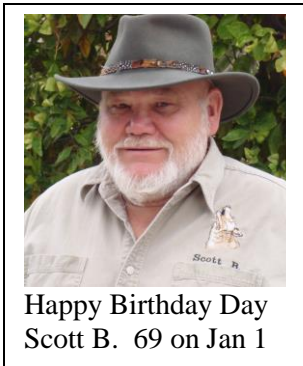

November Club Hunt Extraordinaire !!!!!

At 11:30am on Saturday we were headed down a small two track that followed the bushy river bottom and as we approached a small bowl-shaped area we stopped the truck and headed in. Nathan would call this stand and he was running shotgun along with Tim who sat a few yards to his left. I was on my ladder for the first time ever downwind about 60 yards away. As Nathan called it only took 5 minutes or so and I spotted a Coyote running right at them. As I sat on the ladder I was able to watch as Wiley closed the distance more and more, never slowing at the slightest. 30 yards away from Tim and still on a dead sprint I heard the report of the 12 gauge as the Coyote instantly smashed the dirt coming to a stop with a skid! Nathan got right back on the same rabbit distress and not even 2 minutes later I see another Coyote. This one having heard



the shot is sneaking in a bit more cautiously, but is circling upwind which made zero sense. I jumped off my ladder as he was no longer in my "swing zone." I waited, hoping he would stop where I could take a shot but as he stopped it was always behind brush for me. The Coyote closed to about 60 yards and I assume saw enough of the Mojo decoy that he became uninterested and backed out. Tim and Nathan never saw this Coyote. As he was leaving I woofed as he hit a small clearing, but in typical Coyote fashion it only paused after getting to the far bush. As he started walking again I attempted a 150-yard shot and missed. I shot 2 more times as he ran through the brush, but brush was all I hit. Nathan once again got back on the call as I settled back on my perch for what would be a huge surprise to everyone. As I scanned the desert floor a shot rang out, then another! I bailed off my ladder and spun as there was a Coyote spinning about 40 yards from them. I put a 55gr Spire Point round into his chest as Tim and Nathan both hit him again with their shotguns! Immediately after the war had calmed down we called off the stand and I rushed over to check out what I thought was a double on Coyotes. Nathan exclaimed, "Whoop, I got a cat!" I was so confused....this was a Coyote mayhem stand, surely no cat would be amongst all of these Coyotes! It turns out that Nathan had seen a big Bobcat

working his way in after I shot at the second Coyote that had turned to leave. The cat sat down at 50 yards and then the 3rd Coyote came up behind the Bobcat and both animals exchanged looks and had an intense stare-down! Nathan had managed to call in 3 Coyotes and a Bobcat on the 1 stand, and we put all but 1 Coyote down!

Another stand that sticks out in my mind ever too well happened at the end of the day on Saturday, last light in fact. Tim had been calling for maybe 8-10 minutes when all of the sudden a large Coyote came over the small rise running full tilt right past him at 20 yards. He shot and peppered him with the 12 gauge and the Coyote came running 10 feet past me on my ladder! I jumped off and began my attempt at hitting a 30mph hellhound with the desire to cover as much ground as he could. On my 3rd shot I connected and right as he hit the brush he tumbled but the shot was a bit far back to kill quickly. Tim and I both ran after the Coyote and as Tim closed in he shot him 6 times with his 9mm pistol.....the Coyote was still fully alert! I walked up and put a 45 square in his chest from 10 feet away and this dog just glared right back with a shine in his eyes I can't describe. He was straight up pissed and miraculously alive and fully alert! Not wanting to shoot more pistol rounds and hurt our ears further I remembered Larry's trick where you smack them on the throat with a stick to finish them. Well....I forgot the first part where I was supposed to daze him with a smack on the head first. I took my condensed down 3-foot monopod and as I was lining up the hit he lurched at me, snapped his jaws and clamped down on my sticks only a foot from my hand! As I pulled away the Coyote twisted with all his might and my sticks snapped up at the "Y." Screw it. Tim walks up and put a 9mm right between his eyes and we were finally done. I am continually amazed at just how much trauma some of these big Coyotes can take before expiring!



Tim has yet to call in and kill his first Bobcat, well that was until Sunday of course! We setup on the edge of yet another wash bed that was littered with Bobcat tracks and he began calling. Maybe 8 minutes into the stand Nathan shoots, stands



up to make sure whatever he shot wasn't going anywhere and then turns to give us the thumbs up! Tim went back to calling and only a minute in Nathan shot again, just to finish the animal that he had hit a little far back. After calling off the stand Tim and I headed over to see what he had. Nathan was playing it off as to surprise Tim and as we walked up both Tim and I initially thought it was a tiny Coyote. That was until we saw those classic white and black ears! Tim had his first Bobcat! A smaller but very, very pretty female!

Later on, Sunday we changed areas as to get close enough to make it to check-in in time. I had called in a Coyote but he wined us before I could take a shot. The next few stands were blank, and we headed in deeper. We setup about a quarter mile from a big brushy wash and Tim began to call. Nathan was just upwind with his 12 gauge and I was 40 yards downwind up on the ladder with my AR-15. Tim was setup with a medium stool and his AR-15. He called and called, switching calls a few times within the first 12 minutes on stand. He spotted what he initially thought was a Coyote sneaking in through the Creosote. As he turned up his magnification he saw that it was a Bobcat! He let it close the gap to about 75 yards, lined up and squeezed the trigger. The huge Tom Bobcat took a 40gr Varmagedon right between the eyes and he hit the dirt! Tim let out a yell that told Nathan and I it was something awesome! As we walked up to the cat we were all in awe of how big and how beautiful his pelt was!



MORE TIDBITS AND SUCH by Eddie M.

SELECTING A CALL: Okay, which hand-held predator call should I purchase to use? Good question. There are basically 6 types of hand-held predator calls. They are closed reed, open reed, bite-down and diaphragm, howlers and squeakers-rodent distress. Let's take a quick look at each one and go over their advantages & disadvantages. One more very versatile call to consider that is not covered here is the "Lip Squeak" using your lips.

Closed reed call

Open Reed call

Bite-Down Call

Diaphragm

Advantages:

Much easier to learn to blow.
Good rabbit sounds, some okay bird sounds. Rodent distress with coaxer reeds or if built-in.
Okay with some models in wind.

Extremely versatile call.
Good rabbit, bird, rodent, fawn & howler possible w/same call on many models. Will not freeze-up.

Great variety of sounds
Both bird & rodent, okay fawn & rabbit sounds.
Can call with no hands.
Most will call loud & soft.

Hands-free operation
Versatile, can make with all sounds except maybe rodent.

Disadvantages:

Will freeze up in cold temps.
Fawn distress difficult on most.
Rodent distress tends to get blown-out quickly.
Not a good coyote howler.

Much harder to learn to use. Don't leave these calls in the sun. Esp. with the Tally-Ho, you will damage the reed.

Some have a problem learning how to use. Okay for some distance calling if light winds. Not a good call for big wind. Terrible howler.

Volume can be a problem w/ rabbit.
Not a good call for the wind.

Howlers are calls made specifically for coyote howling. Of course you can also make a decent howl on many of the open-reed calls. Squeakers-rodent distress can be used both as a main call for enticing critters in or as a coaxer should one happen to hang-up on you.

HUNTING PREDATORS IN THE COLD by Eddie M.

I woke up just before the alarm went off & looked around, first at the sky, then at certain features around me. A lot of times when it's dark, you can't see these features (provided there is no full moon) yet as the night gave way to the dawn, these features can be seen. From my sleeping bag on the ground, I could see a juniper tree here, a small pine tree there, a pile of rocks, etc. Sure enough the sky was lighting up in the East & daylight would soon be here. I sat up in my sleeping bag & quietly got dressed, taking special note of a coyote pack howling in the distance. Hoping that others would also answer, I kept my ears tuned & sure enough in a couple minutes, 2 other packs answered from 2 different locations. It was the middle of December & it was cold. My little keychain thermometer showing that it was 21 degrees! "Good, that means that they will have to eat to stay warm," I thought. Normally I don't like going North when the temps are below 25 degrees but this weekend was different. It was supposed to snow that Sunday afternoon which meant 2 things. One, I could hunt the dry, snowless, mudless, north country one more time and attempt to harvest some good thick pelts & two, I could also call in the snow when it arrived.

After checking the wind & loading my shotgun, I headed in the direction of one of the upwind packs. On the way this pack started howling again. I used the noise they were making to get even closer. I backed my way into a juniper tree with a clear view in front that included a couple of shooting lanes. Waa, waa, waa, the sounds of surprised bunny distress pierced the surroundings for just a short bit. I paused about 10 seconds then did another short series and then shut up & slowly counted to 180. As I silently counted my head slowly moved from left to right, checking my zone for any sign of movement. This helped me to avoid tunnel vision. Ninety-eight, 99, 100...suddenly off to my right, two coyotes suddenly appeared from 45 yards out, running hard & racing each other to get to the source of the sound first! They covered ground rapidly headed directly towards my location. I let them come closer, closer, closer and when 12 yards out brought the shotgun up & shot the closest coyote in one fluid motion. While it dropped I swung on the other coyote that had already put on the afterburners & was hightailing it out of there. The next shot was too far back but the 3rd shot folded the coyote in mid-air. It hit the ground & rolled several times before it stopped. I visually checked both coyotes for any sign of movement, one hand searching my pocket for more ammo while I continued calling with the other hand. This was a good start!



Predator hunting in the cold & sometimes snow of winter can be a very fun & rewarding experience IF you are properly prepared. Going unprepared can not only make you miserable (ever had cold frozen feet?); it can also be dangerous & potentially fatal. If heading North at any time of year, I always make sure I have a beanie cap, long-sleeve insulated shirt, good hunting boots & a sleeping bag. In the wintertime I'll carry the same items only my boots will have at least 800 grams of insulation. Any less & my feet get cold, even doing a 15 minute stand in the desert. My sleeping bag is also rated at 0 degrees. Don't forget an ice scraper for the windshield & please be sure to have anti-freeze in your vehicle. Living in the desert some of us overlook this simple fact.

The next couple of stands on the juniper flats produced nothing so I started looking for a terrain change like hills or draws with lots of rocks so that I could get away from the coyotes & concentrate on fox & bobcats. The road eventually came to a draw. On both sides of this draw were hills with rock piles here & there. Out of the truck & up I headed. I set up in the rocks at the base of one of the rock piles looking up. Using my bite-down call this time my distressed bird sound was used. The volume was kept up with a few pauses. I tried to sound like 2 sparrows fighting. Immediately the song birds started showing up, all of them doing their own chirping. Then here came the jays with their loud raucous calls. Around 12 minutes into the stand a gray fox appeared on one of the top boulders & looked down. Since I had the bite-down call I simply kept calling as the shotgun was raised & the shot taken. BOOM! The fox dropped & stayed still. Immediately I started calling again. As most of us experienced callers know, the sound of the shot often seems to have no effect upon approaching critters, unless they are the ones being shot at. Further calling produced no results.

The winds started picking up Saturday evening & the snow came that night. I was snug as a bug in a rug in my sleeping bag inside the tent. Occasionally during the night I'd wake up & hit the top & sides of the tent knocking off the snow. The wind was still howling pretty good come morning but eventually subsided. I mentally kicked myself as I dressed. How can you know that it's going to snow & not bring your snow camo or snow (pac) boots? On my feet were Rocky Wolverines w/ 1,000 grams of insulation so I was okay in the Boot Dept. I really would have liked the snow boots and camo though. I managed to find a lighter colored camo top, this and setting up in front of green bushes seemed to work okay, in other words I seemed to blend in.



I hear howling on a distant hill. The truck is close, so the hill is glassed with binos. Nothing is found until after the howling stops. I watch as 3 coyotes walk up the snow-covered hill. Once they walk over and are out of sight I walk that way & set-up just below where they vanished. I use the bird distress being quiet at first but gradually I get louder. It had taken a little time to walk up here, where were those coyotes? About then a single coyote walks back over the hill in my direction. I killed the coyote in the snow at 17 steps & ended the weekend with 3 coyotes and 1 fox. I've done better & I've done worse. Don't let the cold and/or snow stop you.

Yes, it is that time of year again, the time when nominations for the PVCI Officers & Board of Directors comes to be. Every PVCI position is annually up for re-election in April except for some of the Board Members. The PVCI Officers & Board Members are the decision-making core of PVCI & besides the duties that each position represents they are also required to attend one extra Meeting on the third Wednesday of each month. There is a certain amount of prestige associated with being a Phoenix Varmint Caller Officer or Board Member & you will go down in history as having been elected. The PVCI Presidents especially not only have a place in history but there can also be some FAME that goes along with the position. This is after all a fine Club that is known. If you would like to nominate someone, anyone to be elected into this "Special Group" please do feel free to do so when the nominations are opened at the next few Club Meetings. You are of course more than welcome to also nominate yourself. Here is a brief breakdown of the positions:

President: The Head Honcho, the Main Man. Responsible for running both the regular club meeting & the Board of Directors Meeting & shall direct the activities of this Club.

Vice-President: Assist the President in running meetings & business, also in charge of meetings if President absent.

Corresponding Secretary: Responsible for all club correspondence with the outside, the press, the other clubs, etc. He shall keep a complete file of this correspondence. Also presents documents prior to mailing for Officer & Board approval & submit proof of all mailings. This person needs to have some PVCI letterhead in his possession. This person assumes the President's position in case of emergency or the absence of both the President and Vice-President.

Recording Secretary: Accurately records all club minutes at both the regular and board meetings. These minutes contain among other things, the type of meeting, date and place and time of the meeting, a list of the officers and directors present plus any motions or amendments. Keeps this record in a safe place and is able to furnish past minutes if needed. **Treasurer:** Receives all dues and other funds coming into this club then deposits them to this club's account immediately upon receipt. Keeps accurate records of all receipts and disbursements and is able to render an annual financial statement. Also prepares a monthly report that is entered into the club's minutes during the meetings. The Treasurer keeps the Club's checkbook and he/she pays all the bills incurred by the Club including rent, trophies, locker, mailbox, etc. and responsible for the club's non-profit status and records. The President, Vice-President and Treasurer shall be authorized to sign checks, two (2) signatures being required.

Board of Director Member(s): Must be able to attend two (2) meetings per month, the regular and the board. Votes on issues discussed at board meetings. Also helps in planning and organizing club events, helps decide on the direction of the club and usually chairs at least one committee for the major club events. The Board of Directors is a 3-year term. All of the 5 officer positions are 1-year terms.
