## STORIES FROM YOU THE MEMBERS:

### KABOOM By Ken E



It was a beautiful start - we were on the first stand about ten minutes before sunup, watching the desert light up and listening to the coyotes howl in an arc around us. Disappointing, though, since there was no earth-shattering KABOOM on that stand. The next stand was quiet, too! The third time was lucky, somewhat. Larry said the coyote was suddenly in front of him, looking at him, twenty feet away, but he wasn't down his rifle and looking through his scope, so he froze and let the coyote continue toward me. Surprised me, too! KABOOM I hit it at least twice, I thought three times with my twelve gage but it still ran way with Larry taking another shot. After looking for 45 minutes and finding nothing, we gave up and went for another stand.

Luckily Chris B. forgot the tortillas and cheese on his counter, which forced us to change our location while obtaining lunch. On the first stand after lunch, a coyote ran past Larry, from the direction of the truck, and towards me! Four loads of 4 buck, knocked it down, growling with each shot and a finishing load from Larry and we had harvested our first coyote. One tough dog and I will admit the hide was not in the best shape. Now, we were getting serious.

On the next stand I was six minutes in when I heard the coyote running in, so I huddled down until I couldn't stand it any longer. As I came up, Chris barked, and there it was, about 15 or so yards away, stopped and surprised. KABOOM. One shot and we had two in the bag. So I got back on the call and six minutes later number three went down at about forty yards with one shot.

After dragging them back to the truck we decided to just walk north and do another stand with Chris calling. The third coyote in a row that I heard running in, managed to go right between all three of us and stop about 25 yards away from me, looking back at Chris. Sadly for him my shotgun was pointing almost directly at him! KABOOM. Larry found him down about a hundred yards away- remember to make head shots if you can and go look in the direction they were pointing if you have to search.

It was Larry's turn, now. About 3/4s of a mile away and Chris, the downwinder, took the first shot, second too and then a slower third! After expressing himself, he gestured to Larry to continue calling. Several minutes later, a coyote put the full brakes on and came to a stop 15 yards behind Larry, where I happened to be pointing my Mossberg. Enough said, I think, even though I did take another shot since he managed to twitch once or twice. Score on that stand was one shot and got away, one down, and according to Chris, one coming in but no shot about thirty seconds before I nailed the second.

Four down, but unskinned meant that we spent the last light looking for a skinning tree, which ended up being a sign post on the highway. So I will caution you, try to be more inconspicuous in your choice of skinning trees. We ended up with two DPS trucks putting their headlights on us! The benefit was that we used those lights to finish cleaning up as they ran us for warrants and warrants, they came back clean., this time.

The next day will be a story for another Predator Tales but we did call in three coyotes and harvest two with no shots taken at the first one. I will go back for that one!

I will say that we came in to check-in with seven, patting ourselves on our backs all the way, to find out that Craig B. and his team put us in the first losers slot (Second Place)! Some damn tough competition in this outfit!

These minutes contain among other things, the type of meeting, date and place and time of the meeting, a list of the officers and directors present plus any motions or amendments. Keeps this record in a safe place and is able to furnish past minutes if needed.

**Treasurer:** Receives all dues and other funds coming into the club then deposits them to the club's account immediately upon receipt. Keeps accurate records of all receipts and disbursements and is able to render an annual financial statement. Also prepares a monthly report that is entered into the club's minutes during the meetings. The Treasurer keeps the Club's checkbook and he/she pays all the bills incurred by the Club including rent, trophies, locker, mailbox, etc. and responsible for the club's non-profit status and records. The President, Vice-President and Treasurer shall be authorized to sign checks, two (2) signatures being required.

**Board of Director Member(s):** Must be able to attend two (2) meetings per month, the regular and the board. Votes on issues discussed at board meetings. Also helps in planning and organizing club events, helps decide on the direction of the club and usually chairs at least one committee for the major club events. The Board of Directors is a 3-year term. All of the 5 officer positions are 1-year terms.

**JAVELINA HUNTING THE EASY WAY** by Nick C.

The shrill scream of the varmint call shattered the early morning stillness. Suddenly three dark objects broke out of a wash 250 yards away. They were three nice javelina that were headed straight for us on a dead run!

It was the last day of the 1969 javelina rifle season and Lee Henry & myself were perched halfway up a small hill where I was calling these little gray ghosts of the desert.

I continued blowing on the call, as the pigs had not slowed down. Twice I ran out of wind but I didn't dare stop for I didn't want the pigs to lose interest. The lead pig was a big boar & I saw Lee raise his rifle as they charged in from about 30 yards out. A shot rang out & the big boar toppled. It was then that I dropped my varmint call & took a bead on the second pig that was now veering across. I fired & my pig also went down. At that time Lee commented, "Boy, this calling sure beats walking them up." This was a very valid comment on this particular day for it was only 7:45p.m. in the morn.

I certainly don't profess to be an expert in calling Javelina but I will pass on a little bit of information that I have picked up on the subject during the past few years.

First of all, where should someone go to call for pigs? The thing to do is to look for a place where there is a good concentration of pig sign. By sign I mean tracks, droppings and shredded prickly pear cactus. Once you do find a place that has heavy sign then look for a small hill. Hills are very good to call from because if javelina do respond, you can spot them a lot sooner than you can from a stand on flat terrain. If there are no hills but instead there are brushy thickets, then make your stand a short way from a thicket & call into it. I saw Lee Henry call in 11 javelina in this manner last New Years Day.

I really can't say what is the best technique to use in calling javelina. I guess it depends upon what theory you believe as to why they come in to a varmint call. One theory is that they think that they hear a baby javelina in trouble. So therefore, they rush over to help it. If you believe this theory then you should make your call sound like a screaming little pig.

The other theory is that they come to a call out of pure curiosity. I tend to believe this latter theory, for the times that I have called them or seen them called by others, we called no different than we did when calling for coyotes. So I believe that if you have had any success calling coyotes then you should probably use the same technique for javelina.

Another point that I have experienced several times & have had confirmed by others is that it seems that if you don't get javelina in during the first five minutes of calling that they probably won't come at all on that particular stand. Some time ago, I was on a varmint calling excursion with Jerry P. Vice-President of the Phoenix Club, when Jerry called in 14 of the bouncy pigs. They came in during the first 30 seconds of his initial call. I'd suggest not staying on stand over 10 minutes.

One other tip is that if you have javelina coming in, don't stop calling! Even if you run out of wind, catch your breath as quickly as possible & continue. Many times if you stop the pigs also stop & may not come in any further or even go away. This piece of information was passed on to me by Marion M. well known guide, who's called in hundreds of javelina.

Another statement that Marion made is that it is not always advantageous to call. In fact he said that many times pigs will run in the opposite direction. So if you are walking and you happen to spot javelina, you have to decide whether you want to stalk them or whether you want to call, since there is a possibility of scaring them with the call.

I realize that there are many more experienced callers than myself that will disagree with some of these ideas but these tips have been helpful to me and I hope they are helpful to you. Good Calling!

## FUR PREP DAY – MARCH???

There seems to be a lot of interest in learning how to “put up” or process your own furs and why not? The furs from the pelts that we harvest are a valuable resource. On Fur Prep Day we go through the process of preparing the frozen pelts that we have collected for the Auction or Tannery. We usually take the pelts out to thaw the night before and then meet over a volunteer’s house to do the work. This is an excellent time to learn how to prepare a pelt, as we will teach you the necessary steps so that you will have the knowledge to do your own or teach others. Steps such as fleshing a pelt on a fleshing board, sewing up holes & learning how to use a fur stretcher.

### MY LAST CALLED/SHOT COYOTE by Eddie M.

I really wanted to share the story of my last coyote kill because I believe that it may be of benefit to many of you as you work on your own varmint calling careers. What happen has happen to me before however it had been a while & I was so convinced otherwise that I almost didn’t do something that you should ALWAYS do.



It was the third day of my bighorn sheep hunt in Northern AZ. and I woke up to a very thick fog. Glassing was useless, the day was young, what is an admitted predator calling nut to do? Why go calling of course! I had even heard coyotes howling on the other side of a small hill that separated me from the sage flats. I checked the wind, loaded the shotgun & headed over that hill staying low. I noticed a few coyote tracks here & there & sat my stool next to some kind of taller-than-sage bush & where I had a clear view in front of me. I was wearing a camo shirt that Les Johnson of TV fame had given to me at an Arizona Trappers Assoc. Convention many years ago where he was one of the featured speakers. I probably also spoke about or did something to help the Event. The shirt was kind of big and I remembered that he apologized when he gave it to me but it was all he had left & he wanted to give me something. The colors seemed a little light for me to use here in the deserts, etc. so I really hadn’t used it until now & the bigger size was perfect for the layering system I had on for the cold plus the colors blended in up here. I did one quick surprise-type squall in jackrabbit on the FoxPro bite-down call then stayed quiet as I counted to 180. On about 120, I first see, then hear a coyote coming on a dead run across the flats, I mean just coming all out. Though coming in my direction, it was a little off & about 35 yards to my right. I let it get almost even then, because it was on my off-side, slowly stood and shot twice. The coyote just kept on running giving absolutely no indication that it was hit! I watched in disbelief as it ran across the flats and up over the small hill towards my truck. I guess I must have missed? I sat down and did some more calling then gathered everything up and headed back to the truck. The hard running coyote tracks were clearly visible in the sand and just before the hill I started to follow them, figuring I might as well check to see what it did. I noticed that one paw was going deeper than the others. That did seem a little odd but there was no blood, oh well? I followed the tracks over the hill for a short distance and was actually surprised to see a dead coyote just laying there on top of the sand! Right before where it laid you could see where it had fallen & skidded into a nearby bush then got up, took a few steps & died. There was one bubble of frothy lung blood on the top side.

I had hit the coyote & to think that the only reason I even went to follow the tracks was because it went in the direction that I was headed anyway. The Moral is obvious: Go & check your shots! I’m also becoming a fan of the long pause after the initial calling series or two like Randy A., Larry S. & Ken E. often do.
