TAKE -VS- HARVEST Editorial by Terry J.

For some time now I have been hearing hunters refer to their kill as harvest. Personally, I consider this to be an incorrect usage of the term. Farmers "Harvest" crops (beets, corn, fruit, etc., etc.). Livestock (beef, pork, poultry, etc., etc.) on the other hand is slaughtered. Crops and livestock both are cultivated or raised and they both may be referred to as part of the overall "Harvest" but only in a general sense.

When we hunt, we don't "Harvest" what is cultivated or raised, we take what is wild. If you read the Game & Fish Regulations you will see no mention of the word "Harvest" in relation to game, non-game, reptiles or predator-fur bearers. You will see the word "Take."

By now you are probably wondering what difference it makes? I believe that the use of the term "Harvest" in relation to our sport presents at least a few liabilities and I will discuss two of them.

First I think that many hunters who refer to their kill as "Harvest" do so out of a sense of political correctness to make our sport sound more acceptable to the non-hunting public. I believe that some also intend this, partly at least, to counter the anti-hunting forces.

The problem I see is that when we change our language or our behavior in order to placate those who oppose us, it only serves to demonstrate that their efforts are effective. This emboldens and encourages them, for they will now believe that they can further alter our behavior to suit their desires. Nothing succeeds like success.

If we as hunters convince the general public that we are in the field to "Harvest" these animals, we also give the antihunters the opportunity to argue that since the furs are only prime for a few months out of the year; the seasons should be restricted to only those few months. Also it gives them the opportunity to argue that the "Harvest" should be managed with bag limits or quotas in order to "Protect the Resource."

The anti's know that they can't get hunting outlawed overnight but time & time again they have been successful at reducing seasons or bag limits to the point that fewer & fewer people have the opportunity to hunt or even find the effort to be worthwhile. Those who oppose hunting will do so regardless of how we characterize it or mischaracterize it, as the case may be. The last thing we as hunters should do is give our adversaries "ANY" opening to use against us.

This year I intend to "Take" a number of predators and I hope that everyone else who wants to will have the opportunity to do the same. I don't expect everyone to agree with me but this year, if you feel the urge to "Harvest" something, please do us all a favor and plant some beets.



QUESTION: OKAY I WANT TO HUNT THE CLUB HUNT BUT DON'T KNOW ANYONE TO ASK. HOW CAN I FIND PARTNERS TO HUNT WITH??

This question is a reality for many, many of you members (both new & old) during the hunting season. You want to go hunting so bad that you can taste it however it seems like there is no opportunity because either the same people are always hunting together or you are just lost because you have no idea who is hunting or wants to hunt & wouldn't really know who or how to ask anyway. This is probably frustrating to you also as the desire to learn about predator calling & then to actually have the chance to go hunting is probably the #1 reason you joined the Club in the 1st Place. I have some suggestions that may be of help to you in the future. The following suggestions don't really have an order & should probably all be used in your overall plan.

Bob B. is the Hunt Chairman. Bob is the guy who hands out the awards for 1st, 2nd & 3rd Place during the hunt months. If you really want to hunt, be sure to get your name down on Bob's list whether you have a team or not. Most of the teams signup and pay the \$10 fee that night. You don't have to pay right away though. Get your name on the list; then tell Bob of your desires like how many people you would like to go with, whether you want to hunt one day or two, if you have a 4-wheel drive truck or need a ride with someone who has a 4-wheel drive, etc. Important: Also leave your phone number. There are usually several members looking for someone to go with in the days after the Meeting is over, often desperately so. Bob's phone # is (602) 769-5019 and is on the front of every Predator Tales Newsletter. If you are looking for someone, give him a call & see who he's got on the list. Now if it works out that you find no one or no one finds you and you do not want to go or even if you do find someone be sure to call Bob BEFORE the Hunt starts & tell him yes or no. If you are signed up and the answer is no and you wait until after the Hunt starts, then you owe Bob \$10 regardless if you paid him or not & regardless of whether you went out or not. If you are signed up, then once the Hunt starts, Bob has no choice but to assume that you're hunting, in which case you owe him. If you are not signed up and don't report to Bob who you will be hunting with before the hunt, then you are in reality not signed up & your kills won't count. Remember, call Bob BEFORE the hunt. You can pay him later, like when you come to the check-in.

Hopefully this information will help you in your future hunting endeavors. Have FUN!!! by Eddie M.

PVCI 2011 CHRISTMAS PARTY/POTLUCK/AUCTION REPORT by Ruth S.



"SHOOTING LIONS with SHOT & SOME FORMS of "NIGHT LION HUNTING" NOW LEGAL in ARIZONA!!! by Eddie M.

*** Effectively Immediately (Until at least May 24, 2012). IT IS NOW LEGAL TO HUNT MOUNTAIN LIONS during the day using a rifle, shotgun shooting slug or shotgun shooting shot statewide (except the M units, Check your Hunt Regs.). YOU MAY ALSO HUNT LION AT NIGHT WITH THE AID OF AN ARTICIFICAL LIGHT IN THE MULTIPLE LION BAG UNITS WITH A RIFLE, SHOTGUN SHOOTING SLUG OR (NEW RULE) SHOTGUN SHOOTING SHOT. The Multiple bag lion units basically are Hunt Units 6A South, 13B South, 15B (West of Temple Bar Rd.), 15C & 15D, 16A South, 18B South, 22 South of Hwy 87 & West of Hwy 188 & FR 143, 31 & 32, 37B North of the Gila River, 40A, 42 (with some exceptions & 44A (East of Cunningham Wash). These Multiple Hunt Units are open until at least June 30, 2012 or if/when the bag limit is reached. Please Check Hunt Regs. Remember to report your kill within 48 hours. Also be sure to call 1-877-438-0447 before you hunt and to report your kill.

At least one mountain lion has been harvested at night since the new season began. It was a 7-9 year old female lion. I am not sure which hunt unit t it came from.

NIGHT HUNTING OF COYOTES with SHOTGUN & ARTIFICAL LIGHT A REALITY on MARCH 1, 2012 by Eddie M.

Starting March 1st, 2012 night hunting with the aid of artificial light will be allowed in certain Hunt Units in Arizona. The light may NOT be attached to or operated from any vehicle. The season in Arizona will run from March 1st, 2012 to May 31st, 2012. The Hunt Units that will be open are units 2A, 4A, 10, 13A, 17A, 17B, 31, 32, 34B, 35A, 35B and 36B. These units are all in areas where either antelope or bighorn sheep are in more need of protection.

These new regulations are called Daylong hours. The daylong hours are 12:01a.m. to 11:59p.m. A shotgun shooting shot is the only firearm that may be used. Only coyotes are legal to kill unless you are in a multiple-use mountain lion unit (read above). PLEASE CHECK YOUR HUNT REGULATIONS ON THESE NEW RULES.

As is often customary, PVCI member Craig B. & his team of Chuck D., & John S. showed up last for us with 5 coyotes, giving us 2nd place! Craig called all the coyotes & shot 2. Chuck also shot 2 & John shot 1. I still believe that we could have taken this Event. Fooey on you if you had a critter & didn't show up with it!

This Event will transform the Shooting facility into the largest hands-on Outdoor Expo in Arizona with outdoor fun and adventure for the entire family! Admission & parking to the Event will be totally free! You will have a unique opportunity to test pistols, rifles and shotguns and archery equipment on the range and talk to the manufacturer's reps. Shooters can also learn more about competitive shooting and enjoy some of the specialty ranges not normally open to the public. There will be demonstrations on speed shooting and skeet shooting plus they will have many workshops and exhibition booths displaying the shooting, hunting and fishing sports. Then why not seriously consider running for office this year! This could be the start of a new era in PVCI history. You don't have to be a political person or wear a suit & tie. You DO have to care about the sport of varmint calling & PVCI & want to get involved and want things to matter. Also you DO need to be able to show up at 2 Meetings per month instead of just one. Interested even a little bit? Please look over the list below. EVERY position listed is up for re-election. They say that there are 2 types of people in every organization, those that DO things and those that DON'T. Why is it that the smaller of the 2 groups always seems to be those that DO things? April is election month for PVCI and this year as in every year you the member have a unique opportunity to nominate those that you believe can make a difference for the continuance and betterment of the Club. Do not forget that if you believe that you are that person, that YOU CAN NOMINATE YOURSELF!

The Club Handbook says: The officers of this club shall consist of a president, vice-president, recording secretary, corresponding secretary and treasurer. There is also the board of directors. The officers and board of directors shall be elected from the membership, by the membership, at the regular membership meeting in April of each year. These are the positions and the duties that the various positions entail:

President: The Head Honcho, the Main Man. Responsible for running both the regular club meeting and the Board of Directors Meeting and shall direct the activities of this Club. There can be lots of perks to being President.

Vice-President: Assist the President in running the meetings and business, also in charge of all meetings in the absence of the President. Corresponding Secretary: Responsible for all club correspondence with the outside, the press, the other clubs, etc. He shall keep a complete file of this correspondence. Also presents all documents prior to mailing for officer & board approval and submits proof of all mailings. This person needs to have some PVCI letterhead in his possession. Usually in charge of the thank you letters. This person assumes the President's position in case of emergency or the absence of both the President and Vice-President. Recording Secretary: Accurately records all club minutes at both the regular and board meetings. These minutes contain among other things, the type of meeting, date and place and time of the meeting, a list of the officers and directors present plus any motions or amendments. Keeps this record in a safe place and is able to furnish past minutes if needed.

Treasurer: Receives all dues and other-funds coming into this club, then deposits them to this club's account immediately upon receipt. Keeps accurate records of all receipts and disbursements and is able to render an annual financial statement. Also prepares a monthly report that is entered into the club's minutes during the meetings. The Treasurer keeps the Club's checkbook and he/she pays all the bills incurred by the Club including rent, trophies, locker, mailbox, etc. and responsible for the club's non-profit status and records. The President, Vice-President and Treasurer shall be authorized to sign checks, two (2) signatures being required.

Board of Director Member(s): Must be able to attend two (2) meetings per month, the regular and the board. Also votes on issues discussed at the board meetings. Helps in planning and organizing club events, helps decide on the direction of the club and usually chairs at least one committee for the major club events. The Board of Directors is a 3-year term. All of the 5 officer positions are 1-year terms.

I tried to be as short and through as I could. Hopefully I didn't get anything too wrong. To view a complete list of the officer and board of director duties, look at your club handbook.

UPCOMING PVCI EVENTS:

FUR PREP DAY COMING SOON!!! - Date To Be Announced

(To Be Determined?) 2012 is this year's date for Fur Prep Day! This is the day that is set aside to "put-up" the fur from the Fur Program. Those that have frozen pelts are asked to take them out to thaw the night before at the latest. I float my plastic bags in a cooler of water.

On this day we prepare the thawed-out furs for either the tannery or for sale. First we wash, then flesh them. Next we sew up the holes, then stretch'em fur side in until they reach a certain drying point. Then we turn them fur-side out and put back on the stretchers to finish drying. Eventually the furs are combed or airbrushed to make them look even nicer, then taken off the stretchers and shipped to the tannery or taken to the fur sale. (This year we will again do the tannery.) Once the tanned furs get back, those that helped out on Fur Prep Day are able to purchase furs at a reduced rate. If you have your own marked furs then you will owe the tanning and shipping fee. The rest go on sale to the Club members and to the public at some of the various functions we do.



Make no mistake this is work, especially when it comes to fleshing the critters. Volunteers are needed. The more people that help, the faster the work goes. This is an excellent time to learn what to do with a pelt after the harvest. Lunch and drinks will be provided by PVCI!

The location of the Fur Prep will be (Location to be announced) in Phoenix, AZ. Start time will be 7:00a.m. and we will probably be going all day. Do drop in to help and learn, even if just for a little. Bring a sharp knife or two. Otherwise the Club should have the other fur prep materials.
