Presidents Message

In December the predator populations will be at their lowest level to date. Only those that have survived Mother Nature, human and other hunters and the highways still exist. Can a coyote be educated? I think that they can. If you survive one shot, you've earned a Diploma, two shots an Associate's Degree, 3 shots a Bachelor's Degree, etc. By December I believe there are some coyotes running around with PHD's. They have heard the sounds of yours & the electronic calling, smelled our human scent, heard the report of gunfire and sometimes seem to kind of know the game. Can they still be harvested? Of course they can with the right sound or tactic on the right day. Breeding season (February-) is fast approaching and it sometimes will seem like the coyotes have something other than food on their minds. Bobcats breed at all times of the year yet in Arizona, the best bobcat harvesters that I know say they see more pairs of bobcats in December and January than at any other time of the year. The foxes must also breed in January-February. I've seen the mostly developed pups from foxes taken in March. If they have a 63-day gestation period like a covote, then count back and do the math. It would seem that breeding season (finding a female) and finding an eventual den site would help make you more territorial. Remember this during your hunting forays. There is some good cold-weather fur out there now! Fur is beautiful, utilize the resource!

This Will Be Another Great Opportunity To Expose Predator Calling/Hunting To The Masses & Hopefully Turn On More People To The Sport! New Blood in the form of Participants are needed in all sports to keep the sport alive. Participants (hopefully many) will be needed here too. KEEP THE TRADITION ALIVE – PARTICIPATE! Back in the 60's & 70's there would sometimes be 50 or more callers waiting to compete.

Awards for 1st, 2nd & 3rd Place Expert and also a Top Novice Award.

Hope to see you there. Sign up early. Contest begins at 1:00p.m.

ARIZONA STATE PREDATOR CALLING CONTEST RULES

- 1. Calling contest open to Arizona residents only.
- 2. Points will be total of all the 3 categories on judges score sheet.
- 3. Judges will give points based on how they feel a predator would respond to contestants' hand calling techniques.
- 4. Points will run from 1 to 100 for each category of Volume, Realism & Coaxing.
- 5. Volume: based on if predator would be able to hear the calling at a distance if out in the field.
- 6. Realism: Based on how well the caller imitates a distress cry of a Rabbit in distress, in the first round. 2010 Tyler H.
- 7. Coaxing, based on how predator can be brought closer to caller. Volume lower.
- 8. Round 1 will be scored on Volume and realism in 35 seconds of calling with a second part of coaxing in 20 seconds.
- 9. Time keeper will cut off caller and start coaxing within 15 seconds at end of first part.
- 10. Round 2 will be freestyle calling using any call or any wildlife distress call or any combination of calls. Scoring based on volume and realism.
- 11. Total amount of points will be added and posted on score sheet for round 1 and after round 2 (freestyle) both scores will be added to determine the winner.
- 12. In case of a tie within the first 3 places, a call off will determine the winner of that position.
- 13. Call off will be freestyle for 25 seconds based on rules in round 2.
- 14. Judges will not talk to or see any of the contestants' during any part of the contest.
- 15. Top novice will be selected only between the novice contestants' and not entered in the expert division. Men & woman will compete as equals in novice and expert divisions.

There will be two different categories: Novice (With some exceptions) Those who have not called in the AZ State Calling Contest before. Expert-Those who have participated in the AZ State Calling Contest.

CONTEST CALLING TIPS: 1) Have more than 1 call and blow it before the Contest to make sure that it doesn't freeze up. 2) Practice different routines beforehand and if possible record yourself then listen. Do it from a distance also. Do the same with your coaxer. 3) If a coaxer is called for, use a coaxing-type sound. 4) Bring a howler of some type and know how to howl. This may not be required but just in case they ask for it, you want to be prepared.



Well since I haven't received any new hunt stories, I thought I'd retell an old yet exciting story of something that happen to me. I'll retell my mountain lion story.

BE CAREFUL WHAT YOU WISH FOR – IT JUST MIGHT COME TRUE! SURPRISES ARE PART OF THIS VARMINT CALLING GAME by Eddie M.

No bones about it, I like this varmint-calling game. It gets you outdoors with nature and enables you to see beautiful scenery and spectacular sunrises and sunsets. You get to hear nature's music from insects, birds and animals plus you get to view many varieties of wildlife. Probably my greatest thrill in calling is watching predators and other wildlife come close...but there is one more aspect that I enjoy, that of anticipating the unknown. Simply put, when you blow into a predator call, no longer are you hunting but rather the tables have turned and you are now being hunted. In most every case you never really know just what you might call in. Surprises are part of this varmint-calling game and during my 12 years (at the time, I have 27 years now) I've had many, many surprises. Coyotes bumping into my leg, foxes jumping over my head, hawks and owls landing like that right next to me, close pissed off doe deer that wanted to stomp anything, a bear coming at a dead run and stopping only 7 steps away, to name just a very few. I am very thankful for these surprise experiences and would not trade them. I now have another surprise to share; one that I thought would never happen to me. Never is a BIG word! I'll tell you what I can.

"Mountain lions don't really exist." "They are just figments of people's imaginations." "I call them ghost cats because though I've seen plenty of tracks & droppings, I've never seen the actual live cat." "Do wish I could call one in though, yeah right." I was talking to fellow club member Will H. at his shop before leaving for unit 29's bear season on Sept. 19th, 1997. I was leaving tomorrow to get there a day early and do some scouting and calling. "I don't know, I've got a funny feeling you might get one," said Will.

The next day, just as I got off of the private property and into the forest boundary, it started to rain. There was thunder & lightning and water everywhere. I was glad that I had a 4-wheel drive vehicle! Driving along I looked at the thick oak-covered hills with the white rocks on top and thought they sure looked good for lions but they were also a long ways up. Soon I found a road that headed part of the way up so I took it. It ended at probably the halfway mark. "Well I can walk the other half," I thought to myself. The rain had quit by now & the sun was out. Quickly I got dressed, loaded the rifle & headed up the hill to call for lion. The plan was to stay on stand 45 minutes. Soon I was near the top of a high & wet oak & pine covered hill in unit 29. There were large expanses of big white rocks all over not far away and all was very quiet.

It happen quick, I'd been calling approx. 10 minutes (start time 5:09 p.m.) doing my version of a bird distress on one of Mitch Cain's Modern Calls bite-down call, when during a short pause, I heard what sounded like leaping feet on the leaves twice. Turning my head to the sound I immediately saw a large cat with its tail in the air, very close (7-8 paces away) bounding towards me! The cat was actually in the air when I first saw it, and then landed. There was NO time to think, by the time the cat sprung into the air again, my mind had identified "MOUNTAIN LION" and I just reacted and shot, BOOM! Down the cat went in a heap, her back to me. She was pawing hard at the leaves and trying desperately to keep running. While she lay struggling it hit me, I had just shot and knocked down a mountain lion, get another shot into it! Then the cat was up and gone. She ran straight downhill and I could hear her crashing through the brush for some seconds afterwards, then all was quiet.

Silently I stood. I wasn't scared, just surprised and kind of down. I was sure the cat was hit but didn't know how well. Sure hoped that I could find it but the way it ran away, well it seemed like it could go a long, long ways. The time was now 5:19 p.m. and the distance from where I sat to where she fell was only 5 paces!

After checking several times to be sure that my rifle had a live bullet in the chamber I followed the cats trail in the wet leaves straight downhill, losing it once but finding it again after retracing my steps. The trail again stopped at the end of a point, the drop-off was about 50 feet down. I went around the drop-off and eventually did find the cat, a female (no cubs) in the prime of her life. She was beautiful, powerful, a definite killing machine and she was mine, truly a highlight for the year! Now that I now that these ghost cats do exist and can be called am I done? Heck no! I'm already planning other lion calling trips or calling trips in lion country. Gotta get me a big tomcat! By the way I didn't see any bears.

Sunday morning, Ken E. took out novice Damien out to call and shotgunned a coyote at less than 25 yards, on the first stand of curse! Dale was the person that introduced me to PVCI back in 1998 when we were working together and got me hooked on the sport in about a half a second. Rest in peace Dale Fogelson.


Andy G. - Dale your absence is obvious. Always a support to all who met you. What a legacy.

Eddie M. - Dale was a great guy with a great attitude. He loved his family/friends and he loved to hunt. I was fortunate enough to take him & Dave D. on a Novice Hunt in 1997 I believe. I can't remember how many coyotes we harvested but it seems like it was 6. I'm mainly a shotgun guy & the teachings were passed on as Dale usually used a shotgun on most of his predator hunts. He went on to become quite the caller/hunter. I can remember him introducing his son Abe to calling a short time later. Abe has become quite the hunter too. There are a few hunt stories with Dale that come to mind such as the harvesting of the 6 dogs on that Novice Hunt with Dave. We also once harvested 7 coyotes on a December (fur) hunt. Dale's son Abe was along on that hunt. Since it was the "Fur Hunt," ALL the critters had to be skinned so we took the time to skin them even skinning the last 1 or 2 in the rain. Only to get back and get beat by a bobcat (they were 50 points in those days) & 2 coyotes. The thing was that the bobcat wasn't skinned as it was harvested on their last stand, a clear violation of the rules. Well that night new rules were made and the taxidermy receipt thing rule went into effect and we got 2nd place. (Frown) We also shot foxes in the mountains down South with Will H. and I'll probably never forget how mad he was at himself when he brought a rifle to a shotgun stand and missed a bobcat that I'd called in at 20

PVCI FUR PROGRAM by Eddie M.

The raw furs from the pelts that we harvest are a renewable resource that can be utilized either for your own purposes or for sale. PVCI encourages members to skin their harvest & not just waste them in the field. Now the average new member is probably asking what happens if I harvest 10 coyotes & 5 fox this season? What am I going to do with all of these skins? If you are not going to keep them for yourself then one solution is to donate them to the PVCI Fur Program. This Program encourages you to skin & save your pelts. Participation is easy. Simply skin & save all the pelts that you harvest from late October until Fur Prep Day, which could be in Jan., Feb. or March, the PVCI Board making the determination. After skinning, save your pelts by placing them in a one or two gallon Ziploc freezer-type bag (fur side out) & freezing them, then either store & keep them in your own freezer or if you for some reason you are forbidden to do this, then you can do one of 3 things: #1) Bring your frozen pelts inside the Ziploc freezer-type bags to a Monthly Club Meeting and give to one of the drop-off people. #2) Have your skinned pelts ready at check-in on the Sunday nights (please have them skinned before you get to the parking lot) of the Club Hunts and give to a drop-off person. #3) You can also call one of the drop-off people and make arrangements to take your pelts to a certain drop-off point. Our drop-off people so far are Bob B. (602) 769-5019 We could use more. To volunteer to be a drop-off person please let the Hunt



Chairman Bob B. know at a Meeting or call (602) 769-5019. To be a volunteer, all that you need is some extra freezer space to be able to store other members fur pelts in. Please be courteous when calling a drop-off person. Please, no very

late or very early phone calls. Also, plan on taking your pelts to them. On a certain designated day in the future (probably in Jan., Feb. or March) we will have what is called Fur Prep Day.

Fur Prep Day is a day that is picked where we go through the process of getting the collected frozen pelts that we have accumulated, ready to either sale or tan. What happens is that someone with a good backyard, volunteers his or her house as the Meeting Place. Then on the designated day members show up at this house with the donated pelts that we have been saving. We usually take the pelts out to thaw the night before. Then we go through the process, washing, fleshing, sewing up the holes and stretching the pelts. Make no mistake this is work. The more members that show to help the faster the work gets done. This is an excellent time to learn how to prepare a pelt as we have hands-on instruction going through the necessary steps all day. These fur pelts when done are a valuable resource & PVCI encourages you to utilize this resource and save and learn how to put up your own fur.

The PVCI Board of Directors will make a determination on whether to sell the furs at the ATA Fur Auction or to get them tanned by a Tannery. Lately we have been sending out the donated pelts to the Tannery. When they come back, we sell the pelts to the Membership & to the public at some of the various shows we go too. Money from the pelts donated to the Club go into the Club's General Fund to help pay for the Club's operating expenses such as rent, insurance, trophies, etc. Interested in learning or helping? Keep an eye out in the Newsletter about when this Fur prep Day will be scheduled.

You could also just fill out the form or just jot the details down in a notebook or just keep a photo album. I will try to have some of these pre-printed forms for the January Monthly Meeting. I tried then just started doing the photo albums so now I don't remember all the details. Good Luck


