## PLEASE READ BELOW: IMPORTANT

### **WANTED:** Your input concerning the Notice of Proposed Rulemaking during the public comment period from April 12 to May 12.

The Arizona Game & Fish Commission is proposing to adopt a rule that would prohibit using any lethal method of take during a hunting contest for predatory and fur-bearing animals, as defined under Arizona Revised Statutes 17-101.

In a public meeting on March 15, the Commission unanimously approved a Notice of Rulemaking Docket and Opening and Notice of Proposed Rulemaking. The Notice is also posted at [www.azgfd.gov/rulemaking](http://www.azgfd.gov/rulemaking).

The Notice will be published in the Arizona Administrative Register on April 12, opening a 30-day comment period for the public to provide feedback. All public comments received from April 12 to May 12 will become part of the official record for this proposed rulemaking. There are two ways to submit comments:

All public comments will be evaluated before a Notice of Final Rulemaking is taken to the Commission for its consideration. If approved, the final rule would be reviewed by the Governor's Regulatory Review Council (GRCC).

The Commission's intent in adopting this rule is to address social concerns associated with hunting contests that award prizes to participants who kill the largest number or variety of predatory or fur-bearing animals.

The proposed rule would not apply to lawful, regulated hunting of predatory and fur-bearing animals which plays an important role in wildlife management.

PVCI Members this New Rule if passed "Will" Affect the way that we operate our Club Hunts. We will have to "Not" do something to be legal. It really does seem that the AZGFD wants to pass this New Rule. We are still able to predator hunt which is one thing that the AZGFD does not want to lose. Still, I personally am opposed to changing any part of what we currently have. We are not breaking any rules. Heck, there are more coyotes killed on the Highways in one day than are killed in the hunting contests!

**Here is the Proposed Rule: Participate in, organize, promote or solicit participation in a contest where a participant uses or intends to use any device or implement to capture or kill predatory animals or fur-bearing animals as defined under A.R.S. 17-101. For the purposes of this subsection, "contest" means a competition among participants where participants must register or record entry and pay a fee and prizes or cash are awarded to winning or successful participants.**

The public comment period is from April 12 to May 12. All public comments received from April 12 to May 12 will become part of the official record for this proposed rulemaking. There are two ways to submit comments: Read above.

## One howl! And Six Coyotes Howl Back!

Austin and Billy on the March Novice Hunt. Third stand of the day, Billy's first time calling, & first harvested coyote. Coyote stood up on first series about 200 yards away & came running. She hesitated at 100 yards, one squeak & she came into 20 feet. When he picked his shotgun up out of his lap, she reversed, & he nailed her at 20 yards. The shotgun he used was a Remington 870 that I lent him. I did make him pay me back one load!

One hour earlier, sneaking into a stand, we were busted by a coyote fifty yards short of where I wanted to set up. I backed us out and drove farther down and made another unsuccessful stand. Driving back, Austin called a stand a quarter mile east of where we were busted, with no results. Billy then tried about two-thirds of a mile west of that stand, again no joy. And we were getting desperate because all we had was Billy's coyote from the morning before. This was going to be the last stand of the weekend and it was already after six p.m. Because of the thick

mesquite I stopped after half and mile and we headed in, all of us carrying shotguns. I set Austin up first, sitting on my four-foot ladder and looking east. Heading directly up wind fifty yards I found a nice spot for Billy thirty yards to my left looking south and I was facing west and north. The sunset was pretty but looking into the sun sucked but was still worth a howl. The first coyote was close, to my front and left. The rest seemed to be strung out in a line to the east, all about fifty yards into the brush line and with enough separation to tell they were different coyotes. Jackpot and time to shut up and let them come in. I wait, and wait, and wait. Where is the earth-shattering kaboom? After three minutes I give a quite coaxing using my Pee-wee and wait. Nothing. Time for the Twisted Psycho and desperation. I choked up as close to the tip as I could and went to town. Ten minutes into the stand, three series on the Psycho

and we are losing the light. Is it time to call the stand? Another series with lots of emotion and I hear a scuff from my right and front. A floating rug coming right at me! But it has a head with a white stripe running front to back and claws were showing with each stride. The first shot passed over its back, since I was trying to not destroy the head, cough, cough. And it was only 30 feet out. Second load of four buck was quite effective, though. And the celebrating began! We made it to check in with seven minutes to spare and placed third with a coyote and the badger, not bad for a team with two rank novices. Billy shot his coyote on his first stand as a caller Saturday morning. By the way, Gary A. M. weighed the badger at 18 pounds. I have no idea how old it was, but all the lower front teeth were worn down to the gums.

### PREDATOR CALLING ON YOUR OWN by Eddie M.

I used to go out hunting by myself quite a bit. I really liked going & doing exactly what I wanted. Like making my amount of noise in the morning or walking as far away from the road as I want or going all the way up to that far saddle, etc. There is just a certain sense of freedom that is good. Now there is entirely nothing wrong with having hunting partners, especially in these days & times. However, novices, if you really want your killing numbers to grow, then you have to be able to call and kill critters one on one. The critters then are the teachers, especially when it comes to coyotes. Don't get all dependent to where you have to have others with you before you feel comfortable about calling. You can call & kill something on your own. At the time I wrote this, being without a vehicle the last few years had kind of taken away this aspect of the calling game from me. With the addition recently of another vehicle, I am once again able to enjoy that free feeling again!

The picture is of a decent morning in the field alone. This was the 4th coyote that Chris used his skills to call in that morning. The coyote was completely fooled and came at Chris hard! Chris said that this one made him sweat a little as he was nervous before the shot. He used a shotgun and was able bring the coyote home. One thing to remember if you are hunting alone is to make sure that you have a camera that has a self-timer on it. That way you can also get yourself in the pictures. Do take tasteful pictures to honor the animal. Also pick a spot when you shoot, don't just shoot at the whole critter.

## THESE PREDATOR HUNTER SKILLS HAS MADE A BETTER OVERALL HUNTER

Welcome, welcome, welcome PPCI Member, especially if you are new (we need new blood) welcome! You have joined a fine organization made up of fine individuals. I am proud to say that I have been a member for more than 30 years. If you will open yourself and make yourself available you can make friends here, even life-long friends that among other things should you decide to participate, can also share in the thrill of the hunt!!! (and sometimes not)

Before joining PPCI I like to think that I was your typical, normal person. One day a long time ago, a friend on my paper route that was my age (Vincent) gave me a 6-week old beagle pup. At 6 months old I had that pup running rabbits like a pro. Vincent also had beagles. He also had an Uncle named Bobby that would take us and our beagles to different areas to hunt rabbits. This happen in Ohio and I started hunting when I was 12 following the beagles after cottontail rabbits with my 20-gauge shotgun! There were also pheasants & bobwhite quail. I also trapped muskrats and fished when it wasn't hunting season. When 18, I joined the Marines and ended up back in

my Birth State, California (I left when I was 2). California is a LOT of things! It was the place where big-game hunting was introduced to me. From my home in Bakersfield, in 30 miles I could be in the ponderosa pines on the West Side of the Sierras. California is where I saw my 1<sup>st</sup> bear, shot my 1<sup>st</sup> deer, caught smallmouth bass and trout in the deadly Kern River, limited out on crappie at Lake Henshaw, even fished the enormous ocean! My last 16 months in the Marines, we moved to Yuma, AZ. Here I had to learn to fish and hunt also in order to be happy. Catfishing for channel cat and flathead & gigging bullfrogs at night became the norm. Most hunting was done on the Kofa Game Refuge for small game. I remember one year I killed 51 quail, 31 cottontails & 1 jackrabbit. I used to not want to shoot the jackrabbits as they seemed as big as a beagle & carrying one back to the truck just didn't seem appealing. I'm still normal, right?

From Yuma, I ended up in Phoenix. One day I stopped at this Outdoor Show going on at Sanderson Ford. There were different Outdoor Sporting Groups at these tables. At one table there was a guy named Lew E. that was from the Phoenix Varmint Callers and he was blowing a call. The sound the call made was sort of like a baby crying but with some pain. I looked at some of his photo albums and saw pictures of coyotes, foxes and bobcats. It then dawned on me that these guys were hunting the hunters. I walked up to the table and looked at Lew, cocking my head from one side to the other and asked if that was what the sound was supposed to sound like? "Something like that" he said. He then invited me to a Club Meeting at this Grade School on Indian School Road. I went and joined PPCI that first night, changing me forever.

Skip A. was the first to take me under his arm. If you want to hunt this weekend paint your shotgun. Paint your shotgun? The thought had never even occurred to me. Unpainted rifles & shotguns can reflect like a mirror in the sun! That reflection in many cases can be seen for miles. I had no problem painting that gun whatsoever and to this day have absolutely no use for a shiny firearm. Why I would paint a Benelli in a heartbeat if given a chance without batting an eye.

There was one other Novice on that hunt besides me and early on Skip taught us about wind direction. What upwind, downwind and crosswind was. Every creature downwind of you already knows you are there because they can smell you.

We learned how to "smoke up." What you do is make a fire and let it burn down to coals. Then you put the green boughs of the native vegetation onto those coals. This produces very thick smoke. You smoke your clothes in this smoke until the smoke turns to fire. When the fire is gone you smoke more items. Now you will smell more like the vegetation in the area than a human or that is the hope anyway. Warning: Do NOT put your facemask in this smoke as you will cry all day if you do.

What is the most feared sound in the wild animal world? The sound of the human voice. We learned how to not talk out loud but instead to WHISPER....No, not talk in a low tone, WHISPER! We also learned, just like ALL of you have, to not do the one thing that is the Most Neglected No-No in the hunting world although talking out loud may beat this and that is closing or slamming the door when you get out of your vehicle. Something again most humans/other hunters do not even think about. How many times when you are quail, rabbit, squirrel, deer or elk hunting have you heard the sound of vehicle doors being closed in the distance? Be it in camp, where every time they open the door, they close it loudly to folks that are actually out hunting. They drive past you, pull over, get out, close or slam their door shut and usually start talking out loud. This just doesn't usually work when hunting predators. You are trying to get into an area quietly, make your distress sounds without letting them know you are in the area and dispatch them before they find out they have been fooled. I follow good practices and close my doors quietly even when home. I also learned to not just walk but to try to walk quietly. When growing up hunting rabbits, this is just the opposite of what you want to do. You want to make noise and bust brush then stop and be quiet for a bit, then proceed. A rabbit's best defense is to just be still & let you walk by. If you're making noise then stop for a spell, they begin to believe they've been seen & get nervous enough to run. These learned predator skills & others have made me a quieter, more conscious overall hunter which has helped me in about all my hunt situations. Perhaps, if you follow them, they will help you also.

## ARIZONA GAME & FISH EXPO REPORT

March 30-31 were the dates for the 2019 Arizona Game & Fish Dept. Outdoor Expo held at the Ben Avery Shooting Facility in Phoenix, AZ. off the Carefree Highway. This Event transformed the Shooting Facility into the largest hands-on Outdoor Expo in Arizona with outdoor adventure and fun for the entire family! As in years past admission and parking were totally FREE, as were the shuttles to and from the parking to different points of the event. Once inside there were Loads of hands-on activities, educational presentations/demos & chances to meet with outdoor groups & agencies plus exhibitor booths displaying wildlife & the shooting, hunting, fishing & outdoor sports. PPCI had a Booth at the Event with a decent number of volunteers on both days. Our Mission at these Events is to promote the sport of Varmint Calling. 

**Route #1: On Hwy 87 go through Payson, Strawberry, & Clints Well. Stay on Hwy 87 to the first right (Fr 95) Past the Blue Ridge Range station. Take FR 95 South go approximately 1 mile to FR 513. Camp on the East side FR 513**

**Route #2: Go north on I -17 to camp Verde .  
Turn right on either Exit 287 or 288 .  
Go East on Hwy 260 to Hwy 87. .  
Turn Left on Hwy 87 and .  
follow Route #1 Instructions .**

PLEASE only camp on the right side of FR 513 as you drive in. According to the NEW Coconino Forest Rules; **PLEASE DO NOT camp more than 100 yards from the main road! You will probably be cited if you ignore this rule!** Shooting will be on the left & again according to the New Rules **Please DO NOT park more than 10 yards from the main road on the left side.** \* **Keep ALL dogs on a leash.** Portable toilet will be provided. Please clean up your camping area before going home. Pack out all trash & drown your ashes w/ water & dirt & scatter the camp fire ring rocks. Please bring canopies or tarps for shade, plus extra chairs & ice.

**REMEMBER GUN SAFETY:** No loaded firearms in camp. Please No alcohol & guns. SHOOT ONLY when directed to do so & in designated area. Use the proper firearms for targets.

## **GOBBLER KNOW HOW GETTING HIM TO COME TO YOU** by Eddie M.

**P.S. The Spring Turkey Hunt in 2019 went good for us in New Mexico this year however I will have to tell that story another time. It is opening day in Unit 27 and I am still in Phoenix getting this Newsletter done! I gotta get outa here!**

Hunting the wild turkey gobbler in the spring after the normal predator seasons are over is something that I look forward too with much gusto each year. The process of how I began harvesting these wild birds covers the whole spectrum. I have gone from not really seeing what all the fuss about turkey hunting was about to now counting my life by wondering how many more spring turkey seasons I have left. The many experiences have left me with many memories/adventures...and on some occasions, some good-eating meat too. Every year many hunters get drawn for a turkey tag yet not everyone tags a bird. The reasons for this are varied and many. Let's go on a typical turkey hunt to see if we can't kill us a gobbler.

It starts with signing the turkey tag that you were lucky enough to draw. You've already watched the hunting DVD's & know what the different calls mean. You have also previously visited the unit you plan to hunt on a preseason turkey-scouting trip & know where you plan to camp, plan A & plan B. You also know where to go to listen for gobblers, Plan A, B & C. You arrive at your camp area at least the evening before while there is still some daylight left & your group splits up & listens in different areas before dark, trying to roost some birds. Roosting birds is the term used when you are listening for gobblers as they sound off as they fly up into the trees to sleep for the night. When they do this, they often gobble to let the hens & the rest of the world know where they are. You may also hear wing beats as the birds fly up to roost. The whole idea is to locate some birds, especially gobbling gobblers so that you have a starting point for your hunt come morning. Try your best to pinpoint the gobbler & do not call to him now if you can help yourself after all, this is the night before the opener. As the season progresses, do call to the bird in the evening (especially if you're on top of a hill already) as sometimes, if they are alone, they don't want to go to bed alone & will come to you.

The plan in the morning is to head towards that gobbling bird & get within 100-150 yards while it is still dark. It is very important that you beat the light. Spring is breeding season & if the gobbler wants to breed, then he will start gobbling soon after it awakens. Hens are attracted to the gobbling and in nature the hens go to the gobbler. Turkeys wake up early & trees are tall. If you wait until the light of the morning and then head towards the gobbling bird that is also looking & listening for advancing hens, he will probably spot you from his tree if you get too close. When you are already in position and start to sound like a hen, you'll be more believable. There are a couple trains of thought on what to do next. Some say to wait by the tree and not make any hen sounds until the gobbler flies down. Others say to do some light tree yelping. One thing to not do is to blast the gobbler away with loud calling unless you hear some loud hens close by. Normally if you get too close and make too much noise, the gobbler will often stay in the tree longer waiting for those hens to show up. If he spots you, the gobbler may also stay in the tree or spook and fly off. What I do varies. Usually I'll do light yelping, then (after the gobbler hits the ground) stimulate wing beats like I'm a hen coming out of the tree. Then I just do clucks & purrs plus some scratching in the leaves. If I yelp, it is only sparingly. I don't want to sound too excited unless I hear some excited hens near the gobbler. If you do spot hens coming past you heading to the gobbler, scare them off. If you don't, they will walk past you and take the gobbler away.



Working the gobbler after it's on the ground and trying to get the gobbler to come to you instead of vice versa is where a lot of the fun of trying to call the bird in happens. You can often tell the temperature of the bird by the frequency of the gobbles. Often, I will move closer to the gobbling birds several times trying to seem like an advancing hen. Often also, once the gobbler knows where I am, I will do one of the most effective calls that you can do, SILENCE! Especially later in the season, when they have been called to by hunters often, a little bit of sound and then silence for 20 to 30 minutes can really work! If I hear no gobblers, I walk through the woods (prospecting) sounding like a flock of hens When the gobbler is on its way and gobbling, you will know. Gobblers are loud and the closer they get the louder they will sound. Get ready and have your shotgun already up when the bird shows. Keep your movements slow & remember that sometimes the birds come in quiet. I don't shoot at the head as it moves too much. Instead I shoot just up from where the neck meets the body. I do not shoot birds while they are strutting. After the shot, I run and grab the bird by its legs and hold it up with the breast facing me. I do this even if the bird is still. Almost always the bird will come back to life and start flapping all over the place, similar to a chicken with its head cut off. If you have a hold of it, the bird will stay pretty and not break feathers, etc. This is better for taxidermy purposes. I like # 5 or #6 turkey loads in 3inch & especially like the Federal Turkey or Remington Nitro Turkey Loads.

**Calling in spring gobblers is very exciting.**

**Hopefully this little bit of some tips will help you to get a bird.**

The other Sports have similar Calling Contests** where they learn to call to judges and many also are successful hunters. Anyway, Cabela's used to hold an Annual Event called Predator Days each year. My thoughts were that perhaps we could hold the State Championship during those days? However, since the Bass Pro takeover, Cabela's just isn't what it used to be, especially when it comes to working with the public. The Bow Hunter Happening when it was at Fort Tut Hill near Flagstaff, AZ. was also a Good Place. Any other Event or Location ideas anyone??? If so, please let the PNCI Board know of your idea. This Annual Event was really cherished in the not so distant past. I guess that things really do change.


