2024 Highlights

- We are happy to report that no AIS was detected in our lakes in 2024.
 Early detection of AIS is key to minimizing and controlling the impact of an infestation.
 In late August Stary stonewort was found in Rush Lake on the Whitefish Chain, more information is available on their website. AIS Education Whitefish Area Property Owner's Association This can be worse than milfoil.
- We staffed a booth at Fifty Lakes Day in June.
- Our annual meeting was held at the FL Community Center Aug. 17th and we had presentation on natural shoreline restoration by WAPOA Board member Kristie Roed. We hosted a bags tournament, and held drawings for certificates to Emily Meats, Red Pine Cook House, Glory Hill, and FL Bar.
- We hosted the Fifty Lakes Santa event.

 On December 7rd at City Hall. We had 20 kids again this year, Reed's Market donated cookies and juice boxes.
- We assisted the city with the DNR AIS delegation agreement program. Total funds spent \$16,662
 We had 2 inspectors, hired by the city. Ken and Bob worked closely with the city in scheduling and training. Total inspector hours 952 and total FLPOA funds spent \$9,900 plus \$6,762 State funds managed by the County.
- Our paid-up 2024 membership was 234
 We hope to grow that number in 2025. A special thanks to those members that have made extra contributions.
- We only have 6 board members and some of us have been doing this for 15-20 years! We need another 2 or 3 board members to keep our association going.

- Photograph it and document the location with GPS coordinates from your phone. With Google Maps hold your finger on the screen to drop a red pin, the coordinates will show at the top of the screen like 46.66666, -94.66666
- Save the plant or animal in a bucket of water, to keep if fresh for inspection by the DNR AIS specialist.
