




ARTICLE VII

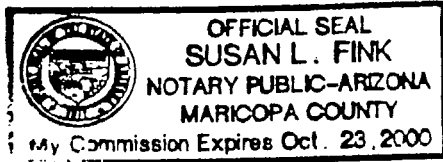
