Roadmaster's Report – Jamie Fries

Jamie informed the supervisors that the garage door was having issues and was repaired. Jamie gave the supervisors a quote for new doors and asked if they would like him to get more quotes by phone or if they wanted to bid it out. Joe Livingston responded to get more quotes by phone.

Jamie presented an estimate for the purchase of a pull behind leaf blower, Buffalo KB7 Turbine Blower, in the amount of \$10,595.00. Joe Livingston made a motion to purchase the blower with a second by Mike Richter. MC

\$5,000 will be paid out of the state fund and \$5,595.00 will be paid out of the general fund.

Jamie also presented Tree Trimming quotes for North Colonial and East Shenango allotments.

Woodland Tree Service \$1300/day, AAA Property \$4000/day and Tip Top Tree Services \$2000/day if more than 1 week \$1500/day. Joe Livingston made a motion to award Woodland Tree Service the job with a second by Mike Richter and Jake Andrew. MC
