

Minutes from Meeting held August 13, 2019

The August meeting of the South Shenango Township Supervisors was held on Tuesday, August 13, 2019 at the South Shenango Township Building, located at 6865 Collins Road, Jamestown, PA 16134. The meeting was called to order at 2:42 pm by Chairperson Joe Livingston. Present were Supervisors Joe Livingston; Mike Richter and Nick Ceremuga. Roadmaster Joe Biery; Solicitor Alan Shaddinger; and Secretaries Cathy Amon and Rebecca Andrew. Three visitors were present. Minutes from the July 9th meeting were reviewed and approved with a motion by Joe Livingston and a second by Mike Richter.
