2. APPLICANT SHALL COMPLY WITH DEP REGS. AND REQUIREMENTS
3. BASEMENT/CRAWLSPACE SHALL BE BACKFILLED WITH CLEAN FILL
4. SILT FENCE TO BE INSTALLED WHERE REQUIRED
5. NO OPEN BURNING OF CONSTRUCTION MATERIALS
6. FOUNDATION MATERIAL SHALL BE REMOVED COMPLETELY
7. IF CONSTRUCTING A NEW DWELLING IN PLACE OF THE OLD A BUILDING PERMIT WILL BE REQUIRED
8. SECURITY FENCE SHALL BE INSTALLED WHERE REQUIRED
9. IF PROPERTY IS CONNECTED TO PUBLIC SEWER. THE PROPERTY OWNER IS REQUIRED TO CONTACT NSSJMA ( 724-932-3138 ) 24 HOURS PRIOR TO DEMO TO SCHEDULE INSPECTION OF DISCONNECTION. PROPERTY OWNERS WILL CONTINUE TO BE CHARGED FOR SEWER UNTIL SEWER CONNECTION IS CAPPED AND INSPECTED BY NSSJMA.
