The June meeting of the South Shenango Township Supervisors was held on Tuesday, June 11, 2024 at the South Shenango Township Building, located at 6865 Collins Road, Jamestown, PA 16134. The meeting was called to order at 2:31 pm by Vice Chairperson Nick Ceremuga. Present were Supervisors Joe Livingston, Mike Richter and Nick Ceremuga; Solicitor Brett Stedman; Roadmaster Jamie Fries; Property Main. Code Official Bob Goff and Secretary Rebecca Andrew. A resident from Douthette Allotment asked if the Township would consider adopting an ordinance not allowing residents to blow grass in the roads when mowing. He said this is a safety concern for motorcyclists and it is a problem in the Township. Mike responded that we will be sending out a notice with the Sewer Authority bills in July.

Bill & Kathy Aubuchon, Ackerman Drive, asked if a watch children sign could be placed on East State Road. They were informed that East State Road is a state road, and they would need to contact PennDot.

Property Maintenance - Bob Goff

Gave a report on properties that are in violation, and he gave the Supervisors copies of all court hearing that are coming up.

Roadmaster's Report – Jamie Fries

Presented an estimate for repairs on the grader and stated that all the salt brine has been placed on the roads.

Attorney's Report – Brett Stedman

Mr. Stedman stated that the Housing Board of Appeals will be meeting next Thursday at 6 p.m. for a hearing.
