The meetings are held the 3rd Thursday of each month – April thru November. The Supervisors had no problem approving the change in the meeting location for Crime Watch.

Roadmaster's Report – Joe Biery reported on the following:

- Jamie Fries built a black top box which they will try out tomorrow.
- The new lite are up and working in the garage/shop. Joe is thinking a couple more would be nice. Mike suggested LED, with a 10 year life span and no maintenance.
- The floor under the conference table will be replaced. Waiting for the tiles to come in.
- Bids for material and pipe will be ready for April's meeting. Stone will go through RFQ.
- Currently, will blacktop a portion of Snake Road, finish Green's Allotment and three miles of single seal. Joe said we have more money than anticipated.
- Douthett Project will cost an estimated \$81,000. The pipe will be bid in April along with the material bids. The Township will do the work according to the DEP permit, which we have.

Attorney's Report – Alan had nothing to report.

Building Code Official – Not present.

Supervisors' Report – Mike Richter is looking into a complaint regarding a property on Lake Lane off of Burns Road. The house is becoming dilapidated, there is a tree down on the property and no one is currently living there. Mike has sent notices before with no results.

Secretary's Report – Cathy had a notice from Crawford Cty Tax Claim Bureau regarding a recent bid on a property in the Township. The property is sold for \$500.00 and put back on the tax rolls for the future. There were no objections to the sale.
