

Minutes from Meeting held May 14, 2019

The May meeting of the South Shenango Township Supervisors was held on Tuesday, May 14, 2019 at the South Shenango Township Building, located at 6865 Collins Road, Jamestown, PA 16134. The meeting was called to order at 2:30 pm by Chairperson Joe Livingston. Present were Supervisors Joe Livingston and Nick Ceremuga; Mike Richter. Roadmaster Joe Biery; Solicitor Alan Shaddinger; and Secretary Cathy Amon. Five visitors were present. Minutes from the April 9th meeting were reviewed and approved with a motion by Joe Livingston and a second by Nick Ceremuga.

Joe also said he would personally contact the State Police in Meadville and set up an appointment to see what could be done.

John Novak, Little Fawn Acres. John thanked the Township for posting speed limit signs in the allotment. John asked about road work in the allotment. Joe Biery said they would fix potholes, but was not planning on any tar & chip repair. John has an updated address for the "crooked trailer". Cathy will relay to John Prosek. John Novak also asked about one of the paper roads in Little Fawn Acres which is a right of way into Warren Cleland's property. Alan Shaddinger mentioned that after 21 years that the property would revert to the land owners. In this case, Little Fawn Acres.

- The weather has kept the crew from salt brining.
- The crew is building a stock yard on Snake Rd to receive 600 Ton of stone.
