#### Alcohol/Commercial Tobacco Action Team

Time: 10 minutes Leader: **Update from SCA** on Tobacco Free Parks Survey from Alysha & Rhiannon.

A survey for residents in the Sauk Prairie area was conducted in summer 2024. Overall, most people residents were in favor of tobacco free outdoor public spaces. Two municipal ordinances exist regarding the use of tobacco products in public parks, however both could use some bolstering to ensure the ordnances continue to have relevance to emerging products and maintain its enforceability. SCA is working with Sauk Prairie Healthcare and the Sauk Prairie Chamber to send a letter to all municipalities that feed into the Sauk Prairie School District asking them to consider strengthening their local ordinances.

#### **Preview of Focus Group Results**

Overall, parents continue to emphasize the harm reduction message around drinking and driving, but not more specific messages around parties or gatherings where underage drinking may occur. Most participants had younger children 12- 13-14 years old.

The action team will consider whether or not to offer another round specifically recruiting parents of older teens 17-18-19 year old.

#### **Leadership Involvement Opportunities**

Elections for Officers of the Coalition will be held annually at the **September** monthly meeting. Chairperson, Vice Chairperson and Secretary are elected to one-year terms; a member may serve more than one term, but cannot serve consecutive terms.

#### **Executive Board Positions:**

- Chairperson
  - Provide leadership and direction for the P4P Coalition; be "the face" of P4P
  - o Serve as head of the Executive Team and preside at P4P Coalition meetings
  - o Call Executive Team meetings for specific reasons, as needed
  - o Appoint ad hoc committees/action teams/work groups as needed
- Vice Chairperson
  - o Assume the above duties in the absence of the Chairperson
  - Serve on the Executive Team
  - o Take over the role of Chairperson in the event that position becomes vacant
- Secretary
  - o Record meeting minutes at all P4P Coalition & Executive Team meetings
  - Serve on the Executive Team

#### **P4P Coalition Active/Voting Members**

Active/Voting Members shall be those persons who contribute toward achieving the coalition's Mission by engaging in all of the following activities:

- Attending coalition meetings as often as possible. To vote on Sauk County P4P Officers
  or other decisions brought before the P4P Coalition by the Executive Team or staff, a
  member must be present and must have attended at least four meetings in the
  preceding 12 months, as tracked by P4P minutes and/or sign in sheets
- Actively serving on at least one committee, work group, or action team per year; and/or contributing to building coalition capacity by helping to raise funds, attract resources, and/or recruit/mentor new members and partners; and/or participating in health promotion and/or substance misuse prevention education or training each year (online or in-person)
- Using time between member or committee meetings to work on coalition goals and activities
- Supporting a data-driven approach that uses evidence-based strategies
