### May 2021 Study Guide

We continue our excursion through the rule book. The rules we encounter this month- Rules 5 and 6- begin the "meat" of officiating that we will progressively encounter.

#### **Rule 5-1-2**

Note that in considering a new series the down, the presence of illegal acts during the down and whether Team A had non-player or unsportsmanlike fouls or Team B had any dead ball fouls MUST be considered after any down but fourth.

After fourth down a new series shall be awarded ONLY after considering any act during the down EXCEPT non-player or unsportsmanlike fouls. Fundamental to both situations is that non-player and unsportsmanlike fouls are always succeeding spot fouls.

#### **Rule 5-1-3e**

Regardless of the down- admittedly scrimmage kicks on anything but fourth down are rare- in nearly all instances the ball belongs to Team R. Rule 5-1-3f describes one of those exceptions.

#### **Rule 5-1-5**

Similar to 5-1-3 with some exceptions. What are they?

# **Rule 5-1-6 First Touching**

First touching occurs at different times and location limits on scrimmage versus free kicks. **This will be asked in depth on Rule 6.** Crews must know these specifics. What cancels the right of Team R to take the spot of first touching?

#### **Rule 5-2**

Many of us find this rule wordy but it lays the foundation for enforcement if:

- A. The penalty is declined
- B. There is a double foul
- C. Post-scrimmage kick enforcement
- D. Kick-catch interference
- E. Fouls by K during kicks and Team R options
- F. Fouls BEFORE and AFTER change of possession

- G. Loss of down aspect to any foul
- H. Fouls simultaneous with the snap

It is easy to miss correct application of enforcement and these fundamentals are critical. Coaches are often confused on these situations.

#### **Rule 5-2-5**

Crews should know when a series of downs ends. This DOES NOT mean loss of possession.

#### Rule 6

This is one of the most critical rules of football as one fourth of plays involve kicking of some sort. During kicks there is moving contact and transition of 22 players. There are special rules involving formations, numbering and these plays pose challenges in correct application of blocking and tackling rules.

#### Rules 6-1-1 and 6-1-2

What are Team K and Team R free kick lines in all situations- free kick after an awarded fair catch, kickoff after a score altered or unaltered by a penalty, kickoff after a safety. What form of kick is legal in these situations?

#### Rule 6-1-3 and 6-1-4

Crew question: What are Team K and R free kick formation limitations and when do they begin?

#### Rule 6-1-5 and 6-1-6

When can Team K recover a free kick? When can they advance after recovery?

#### **Rule 6-1-7**

This is also part of Rule 5.

- A. What defines first touching by K on a free kick?
- B. Where must it occur?
- C. When does Team R lose the right to take this option

#### **Rule 6-1-8**

What three events require a repeat free kick?

#### **Rule 6-1-9**

What are options given to Team R if a free kick goes out of bounds untouched by Team R? This is a very common occurrence and rule options have changed in recent years.

# Let's switch our emphasis to scrimmage kicks although there are similarities

#### **Rule 6-2-1**

Myth: Teams must be in legal scrimmage kick formation to execute a legal scrimmage kick. Importantly, numbering exclusions apply only if teams are using one of two legal scrimmage kick formations.

#### **Rule 6-2-2**

When and where can Team R catch or recover a scrimmage kick and advance?

#### Rule 6-2-3 and 6-2-4

When can Team K catch, recover and advance a scrimmage kick?

#### **Rule 6-2-5**

What defines first touching by K on a scrimmage kick? Are there limitations as to where this can occur?

#### **Rule 6-2-6**

This rule is CRITICAL to understanding how we rule on blocked or touched scrimmage kicks.

### **Rule 6-2-3, Table 6-4 and Rule 6-5**

These rules concentrate on similar aspects of free and scrimmage kicks:

- A. Touchback (This is very different from pro and college rules)
- B. Possession
- C. Where, how and when a kick becomes dead
- D. Fair Catch
- E. Options after a fair catch for Team R- next snap location in particular
- F. Invalid and illegal fair catch signals. The definitions of these are often confused. How enforced?
- G. Where a fair catch can be made? Are there limits based on the line
