Hello neighbors,

At the last board meeting on March 30th, there was a change of the Board of Directors. Ed McDonald, Robert Jones and Donna Stewart resigned from their positions. There was a request from the members in attendance to fill the empty board positions. Jennie Maddox stepped in as President, and Kathy Laney filled the Treasurer position. Diane Stromberger remained as Secretary, which left a three person board. Elizabeth Zeigler joined the board on April 26, 2019.

According to our bylaws, the annual meeting and election is to happen 90 to 120 days before the end of the fiscal year. Kathy and Diane have spoken to the accountant, and the fiscal year will continue to be from August 1 to July 31. Therefore, the annual meeting should have taken place between April 2 and May 2. Due to the board changes, we unfortunately will not be able to comply with the bylaws. The nomination committee, which is being led by Elizabeth Zeigler, must have 30 days to gather nominations for the election as directed in the bylaws.

The annual meeting is set for 1 PM on June 15th at the Gilmer County Library. The election will be conducted at this meeting. We are an organization of volunteers and need a lot of help to make our community and roads better for all.
