

US Election 2020 – From Darkness to Light in Ten Days?

I exercise my right to free speech, and I fully welcome you to exercise yours conditional upon you offering to me the level of respect you would expect from me. If you do not plan to, please stop reading at this point.

What if the attempt to cover up one’s dark deeds is so poorly done that what everyone can see is the covered monstrosity?

What if the darkness of these deeds and the actions of the covering up of such anger and abhor the Lord God so much that He causes such an attempt to fail, and worse still, hand such people over to their own delusions and then to their eternal shame when it is laid bare?

What if God’s Will to expose, judge and punish certain people are given to the hands of the very people that they had sought to slander and destroy?

In my last article released on 6th November 2020, I talked about how the US Election may well find its end in the Supreme Court where the truth is revealed about how many votes are actually cast for both candidates. As we have seen, this did not appear to have happened. In fact, what transpired has been more than surprising in some cases, and also both frustrating and disturbing.

As allegations from the Trump campaign and his supporters regarding irregularities in the way the votes were counted and also the rules that had been changed or ignored in various states were being shown, we saw the clear division of perspectives and opinions among those who followed the election process. The media did much to fuel the divide as both sides aired articles and video footages that sought to either support or cast doubts on what was seen by witnesses and also what was going on inside the polling centres. Claims included that ballot papers were not required to be verified for signature, dead voters casting ballots, polling workers refusing Republican poll watchers from being able to see the votes being verified and counted, certain ballots being run through the counting machine several times and also the Dominion machines used to count and record votes being able to change the vote count to shift from President Trump to Candidate Joe Biden. These claims may be considered fact or

fiction in the eyes or minds of many, but one thing that is undisputable – this election is clearly fraught with problems and history will never be able to write this off.

The way the election was conducted and the votes were counted may seem problematic to some, but none would be able to predict what is to come. For the six weeks leading up to the Electoral College confirmation of votes for each state, investigations and live testimonies in State Legislatures were performed. Depending on which sources one obtained regarding this process, the implications ranged from there is very likely grounds that an organised operation by the Biden campaign, its foreign supporters and the responsible entities of the US system worked together to use as many methods as possible to win this election to the claims made against the Biden campaign are without sufficient grounds. However, what was most disappointing is the open claims by Democrat officials, certain government officials, media companies and the general public who claimed that all these do not amount to anything but a fair and secure election. Such utterances, at least in my opinion, can only be made from the hearts of those who seek not any facts but they have let their sheer disdain and hatred for President Trump and/or his supporters take over their minds. With such behaviour, this is not so much an earthly matter to be settled by human judgment but with almost certainty our Father God will condemn such people as He did those of Judah in Isaiah's days "Woe unto them that call evil good, and good evil; that put darkness for light, and light for darkness; that put bitter for sweet, and sweet for bitter!" (Isaiah 5:20). When the desire to gain what they want overcomes all manners of decency, this may well lead to the Lord God giving them to their own strong delusions and letting them reap the bitter harvest of judgment even as they persuade themselves that victory is secured.

The US Constitution with its three arms of government – Executive (Office of the President), Legislative (Congress comprising the House of Representatives and Senate at both Federal and State level) and Judiciary (Law Courts) were utilised to seek to ensure that the election process and the confirmation of the rightful President. Yet, to no avail. I say to no avail not just because I have a predisposition of what should happen but the fact that the courts and Congress abdicated their fiduciary responsibilities to investigate on the claims made, citing procedural grounds. Regardless of one's opinion of whether there are adequate grounds for the matters to be heard, what was clear was that the State Legislatures in many cases held hearings and people gave testimonies under oath. The findings amounted to overwhelming problems that even if a proper investigation being conducted would not lead to any changes in the election outcome, it would put to rest the doubts of those who raise it. Procedural justice is at least observed, but this was blatantly ignored. Moreover, when the Supreme Court refused to hear not one, but two cases that were docketed by mid-December including one where over 20 states combined to file against the six swing states over Equality of Protection Act, this began to raise the eyebrows of many fair-minded observers who initially may have been neutral or even doubting the election fraud accusations.

From the perspective of those who seek the expedient ways to meet their goals, these past nine weeks since the election must have been increasingly satisfying. I say the term expedient as I assume at this stage, for argument's sake, that they do not hold any malicious intent. They just wanted to get the job done and they observed what they interpret to be the laws governing

the conduct of the election. However, as we proceed, we will soon see that this intent of expediently completing the job is not just filled with mal-intent, but an absolute sense of arrogance and entitlement that would be matched with what dark deeds they are afraid will come out into the open should they not gain back power. Firstly, several states changed their rules on the use of mail-in ballots and the deadlines for submissions of such ballots for counting due to the Wuhan virus pandemic. This offered a plausibly deniable case of the voting irregularities as one cannot ascertain how many “hidden” voters supported the Democrats as they were too scared to come out in public or their states locked them down.

Secondly, many officials involved in the election process have openly expressed their hatred towards President Trump and his supporters and hence put their impartiality into question. There is a difference between having one’s preference and it being so strong that they stridently express it, perhaps as a public badge or display of virtue.

Thirdly, when one seeks to bend rules and regulations or even change them to suit their own ends (such as exercising double standards in applying judgment), this is a sign of character deficiency. When one’s scales are not balanced, they are effectively depriving another of their just desserts. For example, sworn testimonies were made claiming poll workers would defer to Democrats at the expense of Republicans when adjudicating disputed ballots.

Fourthly, many involved in the election process were made aware that there were irregularities and concerns raised throughout the process but they chose to proceed to the next stage without hesitation. This is acting with intent and is grounds for legal confirmation should a crime be established. At every major milestone of the election process, President Trump and the legal teams outlined what has been done, what legislations may be breached and the potential consequences. To proceed thereafter without giving these concerns due diligence and review is intentionally infringing of the law.

Fifthly, and the most concerning above all, is that several who gave testimonies or are charged with reviewing the process – be they legislative or judicial or clerical officials, were threatened openly or in secret to let the process through. This included personal death threats to that of open riots and protests, as was overheard from none other than Chief Justice Roberts himself reputedly shouting to his other judges as for why he was against hearing any cases relating to the election process. The use of threats may sound conspiratorial, but this is exactly what it is. Those who wanted to remove President Trump would go to the most extreme extent to achieve their goal and it seemed like no deed was too low for them. To top it off, any mention of such would be met with ridicule, scorn or even open threats.

Proverbs 6:16-19 lays out what the Lord God hates – “There are six things the Lord hates, seven that are detestable to him: haughty eyes, a lying tongue, hands that shed innocent blood, a heart that devises wicked schemes, feet that are quick to rush into evil, a false witness who pours out lies and a person who stirs up conflict in the community.” Without going into detail as that would be another digression, it goes without saying how these people have committed all of them. Some will protest to say that are not President Trump and his supporters guilty of the same? There is no denying they are innocent of the above either, but to deflect the

warning and furthermore, to seek cover of their own deeds will likely draw greater wrath from our Father God.

So, faced with such seemingly insurmountable onslaught from his enemies that seemed to be so meticulously planned and daringly executed that any attempts to counter it appear to have been fiercely parried, President Trump and his supporters seem to be faced with the dire predicament that they have been offered neither a fair fight nor adjudication. However, this is not the case. President Trump and his administration have been aware of this plan as far back as 2017 when he took office because their enemies have already sought to remove him from office – firstly using the Russian collusion allegation, followed by dragging his past relationships to smear him for lying, the Ukrainian phone call with President Zelensky that led to the first impeachment and then using the Wuhan virus to trap him into either assuming dictatorial powers or to make him appear to fail when Democrat governors coordinated to use fear to lockdown their states, destroy the economy and then lay the blame back on him. The corporate media assaulted him continually with negative coverage and sought to use its longstanding reputation and large market share to unequivocally convince viewers that President Trump is incompetent, malicious and universally hated.

To counter all these, President Trump and his team had studied the playbook of George Soros' Colour Revolution strategy as it had been conducted in several countries in the past 25 years (The Balkans in the early 1990's, The Arab Spring in 2009-2013 and Ukraine in 2014). Rather than resist them at each step, he played along with it and in the investigations they subjected him and his associates under, he collected information to use it back against them. This gave him the ability to use the tools back on them, including the FISA Act that allowed him to monitor all communications of those suspected of threatening national security. Prior to the 2018 Mid-Term Election, he was aware that they would test out ways to win the election with the goal to remove him in the 2020 Election. He prepared two Executive Orders, 13838 and 13848, that would allow him to conduct investigations on election interference, impose serious felony charges on those involved, freeze their assets – whether national, institutional or individual and declare the Insurrection Act in order to bring down this coup. The team monitored the Mid-Term Election closely and several inconsistencies were identified, but they did not act upon it. This was met of course with much outrage among the Republicans who were aware of it and possibly bemusement among his enemies who saw him to be weak and incompetent. Of course, he now had the FISA Act and these Executive Orders to use for the death blow against his enemies for the election that matters. He would know every step and strategy as they were under his surveillance, every single one of them who took part in the 2018 Mid-Term Election fraud.

While President Trump could have stopped the fraud and intervened to have things investigated or even call in the military by pre-emptively declaring his enemies are attempting insurrection (by legal definition, using any unlawful means to remove a ruler from power is insurrection and do not for a moment let President Trump's enemies and the corporate media fool you with their pejorative use of this word), he chose to call out what he observed, state the laws and the consequences and urged them to do the right thing. Brazen and heartened that he was not acting, given they have painted him as an impetuous hothead to the public so

much so that they believe it themselves, they continued. With each stage cleared, more individuals would be involved and hence more would fall under the FISA Act surveillance so more intelligence and data could be collected. This was not just a domestic plot, but one that involved countries, large multinational companies and even the Vatican itself (there was a blackout at the early hours of 9th January 2021, the same day as the Pakistani national grid was taken down as intelligence found that leading Congressional members may have been responsible for selling a major utility to China and in turn, to Pakistan).

On 6th January 2021, President Trump's supporters heeded his call to gather en masse at the Capitol Building, seeking to show the Congress the support for him and letting that bear testimony to the Congressional member as a last appeal to do a proper review of the votes. Inside the Capitol in the Joint Session coordinated by Vice-President Mike Pence, there was initially a debate as the electoral college votes for Arizona were being counted. Midway, the session was interrupted and a recess was declared when the crowd outside had apparently closed in and several had entered into the Capitol Building. It is believed, and history will give this claim justice, that both Antifa and Trump supporters swarmed into the building. Some acted violently smashing windows and assaulting police and law enforcement officers. In the end, five people died, including three police officers. During this incident, several laptop and electronic storage devices were taken from certain Congressional staff members, including Speaker Nancy Pelosi. President Trump, Rudy Giuliani and Lin Wood had earlier tweeted that Trump supporters should protest peacefully and follow instructions from police, stating that they are friendly to them. When the incident occurred of the breach of Capitol Hill, President Trump tweeted both a video and verbal instructions for protesters to clear out and go home and end the violence. The video was deleted by Twitter claiming incitement of violence, which is indeed most surprising and ironic.

What happened thereafter became another media circus, with both sides of the media reinforcing their perspectives. In my opinion, both sides may have been responsible for the violence. However, looking at the playbook of the Colour Revolution and seeing precedents in Ukraine, for example, it is highly likely that the Antifa members who were sent into this event would have clashed with Trump supporters and hence seek to escalate the situation and let it spiral out of control. Thereafter, this would goad President Trump to send in the army and cause an international outrage.

That failed. Much to George Soros' disappointment, the Capitol Building breach did not result in Washington DC burning down and a civil war taking place. That did not stop the corporate media pushing this narrative and seeking to milk this crisis even though there would only be dribbles.

Not only did it fail, but President Trump had already taken this opportunity to quietly invoke the Insurrection Act, without a civil war breaking out. However, for the Capitol Building breach, his enemies have decided to make him responsible for inciting violence to seek to overturn the election results that they claim are legitimate and would remove him from office. The Democrat Party, led by Speaker Pelosi and Senate Minority Leader Chuck Schumer, sought to use the 25th Amendment or a second impeachment to remove him. The 25th

Amendment will likely fail because VP Pence will not support him. So with that, the question remains: Did VP Pence really betray him or did he play along to allow for the operation to allow for the Insurrection Act to be invoked and laptop seizure with the Insurrection Act in effect declaring certain people responsible to be subject to search warrants to find evidence of sedition?

In all this, President Trump is waiting for the right moment to make his moves. What moves will he make?

Throughout all these years, the dark deeds of many in the country from both sides of the aisle in politics, in high society to the suburbs and ghettos and in various organisations have been so great that the land screams from the innocent whose blood was shed and those whose injustice have been unheard. The people who could bear it no longer found the man who would fight for this, President Trump. Rightly or wrongly, the military decided to take him up and prepare him for the 2016 election and also through his four years. They had used the Constitution to ensure that they would be above criticism, but not without harsh scrutiny. They laid their net and even incorporated that of the enemy who sought to ensnare him. He restrained himself from hitting out early for fear that this would foil the plan to bring down what they called the swamp – the cabal of occult left followers who sought to dominate the world and install a global socialistic regime. Instead, as their blows were parried he resisted the temptation to spring that trap, waiting for the next skirmish to let him see who else that pledged to support him turned traitor and sought to dispatch of him.

But how come he could survive for so long? Is he not being abandoned by even his closest people and are his supporters and party members deserting him? The truth lies in the negative. President Trump is not loved by all, but those who love him among the nameless rank and file, there is something about his passion and willingness to actually fight against those in power that they would pledge to fight for him and no one else. While many high-ranking generals publicly decry him, these generals have very few soldiers who would die for them, and others are retired so they hold no sway. He went against the norm of other Presidents in fighting Congress to bring the army home from endless foreign conflicts, increase defense spending so the army would be stronger and also made sure veterans would be paid sufficient benefits rather than return home destitute and having to sleep in the streets (I personally was heartbroken to see in my 2011 trip to the US West Coast to see many homeless people were veterans who were given the short end of the stick). As for the police and law enforcement agencies, the protests and riots endorsed by the Democrats over race relations and called darkly as “The Summer of Love” gave President Trump the chance to win them over when he pledged his unmoving support of them, amidst the outrage from the left in Congress, Hollywood and also the media. Sun Tzu’s “The Art of War” says that a successful general is one who lives among his soldiers and act like one so much so that they would die for him. By October 2020, almost all military and law enforcement groups pledged their votes to President Trump, even in New York, Pennsylvania and Las Vegas. Being the Commander-in-Chief, while it may be good to have generals assist him, he holds his own and it would take much to topple a leader who has solid military support.

Almost all signs point firmly that while President Trump is no perfect man, far from it, but his task of draining the swamp had made him the man with a target painted all over him. His enemies sought to remove him for fear of their deeds being brought out into the open, much of that which would put to shame even the most wretched vagabond when we know about it. Thus, to prevent this, they devised the most ingenious plan to try to remove him and in doing so, may well have incited so much anger and wrath from the Lord God that the hammer of justice, both divine and earthly, are about to fall.

With 15 000 National Guards now in Washington DC as at 11th January 2021 under his command, there are ten days left. Will darkness give way to light? But what light will it be – Godly or earthly?
