

MARKET LAVINGTON VINTAGE MEET FAMILY FUN WEEKEND
CONDITIONS OF ENTRY

The site is open to the public at 10:00hrs and closes at 17:00hrs.

The landowner Market Lavington Parish Council is unable to accept liability for personal damages, losses, or injuries sustained during the event. Any personal property brought to the event is done so at your own risk.

The Council reserves the right to refuse admission.

No alcohol is to be brought on site by members of the public. Alcohol is available from the licenced bar.

The Council shall be entitled to confiscate (1) any items listed below and (2) any other item that we consider to be dangerous or inappropriate. The Council shall not be liable for any loss, theft or damage to confiscated items. Prohibited items are – alcohol, air horns, BBQ's, Chinese lanterns, firearms, fireworks, flares, gas canisters/cylinders, glass of any kind.

Visitors: Tickets will be issued on payment of the entry fee, including tickets for free entry categories. Please keep them in your possession during your visit to the event. You may be asked to produce them. If you intend to leave the event and return the same day a hand stamp will be required.

Exhibitors & Event participants: A wrist band will be issued to be placed on your wrist. This must remain intact through the whole time you are on site, if you remove the wristband you will be challenged by site security or a volunteer. If in the event the wristband becomes detached, you must go to the Event Control where a replacement will be issued in exchange for the broken wristband.

All pets must be on a lead. Please clear up after your pet. Water bowls and waste bags are provided around the field. Any animal left in a vehicle will be reported to the RSPCA or the Police. We will, if we believe an animal is suffering, remove the animal from the vehicle and hand it to the appropriate authority. We reserve the right to use reasonable force to enter the vehicle if necessary. There are no kennels on site.

Search is a condition of entry and presence at the event, including random searches during the event.

This is a family event and unruly behaviour including excessive swearing will not be tolerated.

Strictly no trading on site without the Council's consent.

You must comply with any reasonable direction of a volunteer. If any volunteer is threatened in any way or you fail to comply with the instructions of the volunteer, you will be asked to leave the event.

For the purpose of promoting this or any future events only, your entry is explicit consent to your image being used in any promotional material. The copyright of which will remain the property of the organisers. Your attendance with anyone under 18 years of age means that you give the above consent on their behalf. This includes filming by the police or security staff for the purposes of detecting and recording criminal acts or anti-social behaviour.

We will not accept criminal activity or anti-social behaviour in any form, including criminal damage/fighting/use of illegal substances. If such activities are engaged in, the perpetrator will be asked to leave the site and the police may be called to attend.
