Field Day Observations

Statistically, this was one of the most successful Field Days CFARS has participated in. However, when you peel the onion back, the Devil is in the details. Realize I spent most of my time in the CW tent, so it may appear I am overly critical of that section. Not so, it is where most of my observations took place. I am sure other sites had their problems.

Participation: Attendance was disappointing, there were a lot of new members that we expected to show up that did not, as well as a number of the older members didn't show. I may be old fashioned, but I believe that when you are a member of a club, that really only has one major function a year, you should make every possible effort to support the club in that endeavor. I must ponder when a member makes plans that excludes their participation. Hey guys, Field Day happens every year at the same time. It shouldn't be too difficult to plan around it. Nuff said!

Operationally: Realize I am a neophyte when it comes to setting up a Field Day site but I do have a modicum of common sense. The recommendations I am offering are based on my observations and past experience setting up major base stations in the Army.

I believe that we need a larger footprint for the Field Day deployment. I feel we need to open up more to minimize the inter station sound distractions. I realize it is one of those things that we have "always done that way" but that doesn't mean we have always been right. Maybe if we had a "Field Day Committee" they could scout around for several optional sites ahead of time, as well as address several of the problems that that tend to sneak in at the last moment. The generators should be set up with provisions for a shroud to minimize the sound impacting on the operational area. Maybe a set up rehearsal by discipline, SSB, CW, GOTA, to ensure everything needed is packed, checked out, and ready to go. Evaluate what is necessary, and what is fluff. I realize that in the case of the CW section, (which is where I spent most of my time) each operator wants his own key/ set of paddles, but they should be checked out ahead of time for compatibility with the rest of the components prior to actual set up. Cabling appeared to be more of a problem than it should have been.

Logistics: Each section needs to have a complete list of what is needed to operate. This ranges from radio equipment, to computers and monitors, to basic supplies such as pens, pencils, note pads, and considering a portion of every Field Day is in the dark, lighting should be a major consideration. It is a lot easier to plan for these scenarios than to jump through hoops at the last minute.

Antennas: Do we really know what the actual rules say about the timing of setting up and hooking up antennas? I feel we are playing by antiquated rules when it comes to the timing, and in fact, hooking up our antennas. Check the rules. The Hex Beam should be fully wired. The back side of each band serves as a reflector. I shudder every time I watch the mounting of the CW stations beam. I bet there is a safer way to do it.

In Closing: More detailed planning, pre-packing, try to locate a couple of different locations, consider having a Field Day Committee with one overall director.

Remember: Although I can be a horses butt, in spite of this critique I fully realize, CFARS excelled operationally!

Parks on the Air (POTA) By Mike KN4XP



Are you looking for an exciting challenge in amateur radio? If so, look no further than Parks on the Air. Some may ask just exactly what is this Parks on the Air. Some may have already heard of it. So many questions may come to mind? What does it cost? What equipment do I need? Where and how do I participate?

Parks on the Air is a challenge to work parks across the United States, Canada and several other countries. You can work the parks in several different ways. Depending on your license class and preferred operating mode you may have everything you need to get started.

If you hold a general, advanced or extra class license you already know the world is open to you. There are so many different activities in amateur radio that no one can be proficient in all of the areas. So pick out your mode of operation whether it be ssb, cw or

digital. Get ready for a fun time on the air.

Let's discuss parks in this program. Not every park is eligible to be included in Parks on the Air. For a park to be considered it must not be a private park. It must be one of the following a state park, a federal (national) park, state game lands, state forest or a national trail. You must be able to gain access to the park by a public access road. You can't just go out to a local park, usually owned by a city or county, to activate it for credit in the program.

So just how do you get involved in Parks on the Air? First thing you need to do is go to parksontheair.com. You will need to create an account, which is free. There are some rules that you must follow. Give it a little bit of time and your account will be approved. The reason for the account is so you will get credit for the parks you work. On the website you will find a frequently asked question tab. It has a lot of good information to help you out.

There are different ways to participate, either as a hunter or an activator. Let's do some operating as a hunter to get the hang of working parks. Sometimes it is like a rare dx country when they say QRZ. You might hear a pileup of stations. You will learn to work through the pileups in a quick timeframe. Once you get the hang of working as a hunter you will decided to go out to activate a park.


