The President's Corner: David WD4NC

Hello Club,

I had a chance to sit down and send some questions to Bill Morine, (N2COP) the Section Manager for North Carolina for the ARRL from 2010-2014 and Vice Director. It was nice of him to answer back, and it is a good read. I hope you enjoy.

What would you ask the ARRL?

How will you encourage the next generation of Hams? The average age of ARRL members is 74, and our best guess for all Hams in the U.S. is age 56. Ham Radio needs to be exciting to young people. For example, there is a group at ARRL looking at using Amateur Radio to mimic a video game. We also need to convince policymakers and regulators that Amateur Radio is a national resource as it was once viewed by the public and government officials.

What got you into Ham radio?

My 14-year-old neighbor who was two years older than me had a daily sked on 20 meters with his father who was in the merchant marine. I was fascinated that we could talk with someone at sea for free. From there I got into AM DXing, CB and finally got my Novice ticket.

Follow on, what lead you to being the ARRL Rep?

I have enjoyed the hobby so much for the past 54 years that I felt an obligation to give back. I climbed the ranks of ARRL by being appointed in 1993 as an ARES Assistant Emergency Coordinator for New Hanover County (Wilmington, NC), a position I still hold, then onto being a Public Information Officer (PIO), Public Information Coordinator (PIC) for the North Carolina section, and then Section Manager for North Carolina from 2010 to 2014

What is your favorite part of Ham radio?

Almost everything. The award I treasure most is ARRL's Triple Play Award – all 50 states each on CW, Phone and Digital, all confirmed on LOTW – 150 confirmed contacts altogether. This was much harder than earning DXCC. I've come to enjoy FT8 and FT4 very much – amazing what you can do with low wattage and a simple antenna. And let's not forget QRP. I've owned a Yaesu 817 since

2000. Although I haven't done a lot of POTA, I enjoyed QRP QSOs. And, yes, I own an amp, mostly for 75-meter nets.

How many miles have you traveled this year for the ARRL?

By the end of 2024 I will log about 2,500 miles on behalf of ARRL. I drove 924 miles for Field Day this year visiting seven sites in Virginia. In my role as Vice Director, I am expected to attend every hamfest designated a convention by ARRL. That's two (State and Section) in each state in the division, plus the one designated Division Convention each year. That's a total of 9 minimum Hamfests I attend, but I also attend non-convention Hamfests such as the Cape Fear Swapfest. Plus, I drive to club meetings.

Could QST go out again as a hard copy once a quarter?

This is unlikely to happen. Only 22% of members have opted to remain with the print edition. The Finance Committee looked at publishing, print and postal costs, and the League is losing money on the \$24. subscription fee for print editions. Most members have transitioned to digital and enjoy getting access to all four magazines as part of membership – QST, On The Air, National Contest Journal (NCJ) and QEX. Members paid to keep getting the QST Mag and have not received it yet. It has been since Jan and they did pay extra for it, calls to the ARRL were of no help. Give me the names and callsigns of those members impacted and I will troubleshoot with headquarters. Please keep in mind that the May 13 cyberattack on ARRL disrupted many, many systems. Staff are struggling to restore many systems and it will likely be 2025 before everything is back together. I can ask staff to investigate individual situations to see if we can get the problems resolved.

What are your thoughts on how to increase interest in Ham radio?

I have an unusual answer – be open minded and accept that younger people not only have different interests but also participate in Amateur Radio differently. For example, younger Hams tell me they don't want to go to Saturday morning breakfasts or a monthly meeting. Many typically jump on continual video and social media chat groups to socialize on demand at all hours of the day. One of the largest growth areas which attracts Technicians is drone control. Just because you don't see younger people doesn't mean they're not there – they are but do Ham Radio in ways different from senior Hams.

Where do you see Ham radio in 10 years?

I see a rapidly changing and very different landscape. I expect fewer numbers of traditional modes and customs such as HF ragchew nets and voice only repeaters. Many traditionalists will have to accept that digital modes via the internet have at least one wireless hop, and that hop is technically Amateur Radio, even though QSOs may not be point-to-point. Video transmission will become common place, and the lines between the internet and Amateur Radio will blur into one seamless path in terms of delivery, but those of us licensed will still be responsible for the Amateur Radio segment of transmission. And expect an explosion of highly efficient digital modes to appear – modes which can compress large amounts of information into limited bandwidth. The January 2024 symbol rate restriction removal by the FCC cleared the way for development of a new generation of digital modes.

What can we all do to make Ham radio better for everyone?

There are over 700,000 licensed Amateur Radio operators in the U.S., but we estimate about half are inactive or will let their licenses lapse. Only 38% of Hams get on the air after passing their first

exam. Surveys show they need mentoring. Later I will suggest a way of reaching out to new and returning Hams with a "coffee shop" technique, which is a regularly scheduled weekly get together in a neutral setting on a weekend afternoon. Successful clubs recommend weekend afternoons, like 3-5 PM, because many families are tied up on Saturday and Sunday mornings.

What would you like to tell the club in general?

ARRL examined what made clubs successful during and after the pandemic. The #1 contributor to club growth was making monthly meetings available both in-person but also at the same time via videoconferencing, mostly through Zoom. Members who live far away, those who are incapacitated and those who no longer drive at night can join the meetings and feel connected. Even nonmembers curious in learning more about Ham Radio can join a video meeting. Secondly, consider having a time and place for people – both members and non-members – to consult with experienced Hams for troubleshooting and the most frequent request: programming their HT. Some clubs sponsor such a time one hour before the regular meeting time, but other clubs schedule one-to-twohour sessions every Saturday from 3-5 PM at a local coffee shop. The term "Elmer", while still sacred to older Hams, is viewed by many as old-fashioned so many clubs refer to "mentoring" or "troubleshooting and Q&A session". Two of the most common complaints I hear from new and returning Hams is that their calls on club repeaters go unanswered, and members don't wear badges, so they don't know who they're talking to. For Hams licensed in the 1990s returning to the hobby after a 30-year absence, their FM analog HTs still work, so they buy a fresh battery and expect the local repeaters to be as active as they were years ago. Please try to monitor the club's repeater as much as possible to engage these newcomers and established Hams coming back after many years. Also, many Hams have gotten away from wearing badges to meetings and functions. As one Ham without a badge said to me at a club breakfast, "We know everyone so why wear a badge?" Well, I didn't know him, and neither did other visitors that morning. Wearing a badge shows pride in our hobby. Many clubs have temporary adhesive badges and a sharpie from an office supply store at club meetings, so visitors feel they become part of the club and part of a larger community.

Finally, CFARS is facing the same challenges most clubs are also encountering – how to get and retain active members. According to QRZ.com, there are 893 licensed Hams in Cumberland County, and the size of the club is 132 members according to the ARRL database. That's 15% of all Hams in the immediate area who are CFARS members, and that 15% falls in line with most clubs. To make Amateur Radio more appealing to all, I encourage members to be outgoing, encouraging and open minded with all who show an interest in Amateur Radio.Talk to neighbors, friends and family about what you do, how Ham Radio is exciting to you, and is a community asset in times of trouble. CFARS is a shining example of what makes a good club. Please keep up the good work, and I hope to C U DN the log SN.

The request has been sent and received. We are now waiting to see if the Club will be a recipient this year. I will note that this is the first attempt to submit for a grant, and I think we will probably start to look around and see if there are any other areas that are offering grants in radio. If you know of such a grant, please let us know.


