Mary Hoffman, WA4NC, North Carolina Section Manager



This will be the first in a series of articles on our elected ARRL officials. The first one and the official we deal with most is North Carolina Section Manager Marv Hoffman WA4NC, who undertook the responsibilities in April 2020.

Marv is a resident of Boone, NC and Past President and Life Member of the Watauga Amateur Radio Club. He owns and maintains uhf Mototrbo DMR repeaters on Rich Mountain (Boone) and Sugartop (near Banner Elk) that are part of the PRN system, and several others in the area.

Public safety activities have been a big part of his life, having been a volunteer fireman and fire chief. Marv serves as the Watauga County ARES/Auxcomm EC and the Assistant DEC for Area 12 in Northwestern NC. He is a Type III AHIMT COML, COMT and Liaison Officer with the Western Branch EM Office. He is credentialed as an instructor for the AUXCOMM course

through Homeland Security.

Typically we will see Marv at hamfests and operating events such as Field Day and the North Carolina QSO Party in the near future, covid permitting. He is our 'goto' guy with ARRL.

The Section Manager is our first line contact with the ARRL and has a very extensive list of responsibilities and duties, far too many to list here. But the one I think that affects us most is: Conducts correspondence and other communications with ARRL members and affiliated clubs in the Section; makes personal visits to clubs, hamfests, and conventions; responds to members' questions and concerns or refers them to an appropriate person or office in the League organization; maintains liaison with representative frequency coordinator(s) having jurisdiction in the Section.

Next up - the 10-10 Spring Digital (24-25 April). So get ready to get those Digi-modes revved up and get ready to come out and play.



Winter Field Day 2021 A New Experience By K4PGM



Everything is different now that COVID 19 is lurking around. The enjoyment of spending some time with other HAM operators and setting up a remote station seems to be an ancient memory. Realizing that the usual routine for winter field day was not destined to happen this year I tried to plan a way to make my participation get me into a unique area. It was too cold and wet for this old man to venture outside for 24 hours so there had to be another way. Where could I set up my station in a warm dry place and still have the joy of deploying antennas and operating away from home? Then I thought about the local fire station and how some of the fire fighters had shown an interest in amateur radio. That was the answer and

all I had to do was ask. I was given approval to setup at the station and encouraged to also setup during storms to provide communications should "all else fail".

A tour of the property helped me to determine a location for the G5RV that I had in the workshop. It would cover most bands and that would be the easiest to install. A water (beer) barrel Setup was there for hose training. It consists of two wooden poles with a steel cable strung between them and a barrel attached that slides along the cable. The firefighters compete by moving the barrel with the stream from a fire hose. It was an easy task for a young firefighter to throw my rope over the cable and I attached a pulley for the antenna to be





raised. The ends were tied off to a fence on each side and the coax ran to the ladder line. Latter after testing the HF antenna I installed a dual band J-pole on the patio cover to be able to connect to the repeater.

I removed the ic7100 from my truck and set it up inside the station by the door leading out to the patio. The Wi-Fi router was located just a few feet away and plenty of outlets for power. It took very little time to setup the table and equipment. I did encounter a problem with a PL259 and installed a
