Photo Booth Package

- Unlimited Prints: Enjoy unlimited photo prints during the event.(If you have selected **UnLimited print** package in the rate section)
- Picture Covers: Protective sleeves are provided for guests to use if desired. (If you have selected **UnLimited print** package in the rate section)
- Sharing: Photos can be shared via text or email. An online link will be provided on the next business day.

TERMS & CONDITIONS: Power outlet required within 25 feet of booth. Photo Booth requires minimum space of 6'x8' (full setup 10'x10'). 360 Video Booth needs minimum space of 10'x10' (full setup 15'x20'). One small table provided for props.

FX PICTURES is responsible for the delivery, setup, breakdown, and maintenance of the photo booth during the scheduled rental period. Rental hours are consecutive with no breaks. Any breaks in the photo booth's operation will incur additional charges at the idle hour rate. We will arrive 30-60 minutes prior to the rental for setup. Early setup can be arranged for an additional fee based on idle hours, charged at \$60 per hour. The rental includes unlimited photo booth sessions during the rental period.

DATE CHANGES & CANCELLATIONS: Once booked, dates are non-refundable. We can accommodate date changes if Fx Party booth is available. If Fx Pictures is unavailable for the new date, the contract is canceled, and the retainer fee is non-refundable. However, the amount can be applied towards other services, and we'll hold the credit for one year. Please inform us at least 60 days before your event for any changes.

OUTDOOR EVENTS: For outdoor setups, ensure the location is flat, dry, and either paved or grassy (no dirt), with protection from extreme weather conditions like wind, heat, cold, and direct sunlight. If using the photo booth outdoors, arrange with the provider beforehand. The client is responsible for ensuring the booth is under protective covering and on level ground. If inclement weather occurs and suitable cover isn't provided by the client, the photo booth services will end without refund.

MODEL RELEASE OPTION: Client assigns Fx Party Booth / Fx Pictures LLC the irrevocable right to use and publish photographs of the Client and guests. Client releases Fx Pictures from liability arising from the taking and processing of photos, including any subsequent publication.
