1. *Dave Freedom plans to attend a protest in downtown Ottawa on Friday, April 29<sup>th</sup>, 2022 on Parliament Hill at 6 p.m. and Saturday April 30<sup>th</sup>, 2022 starting at the War Memorial at 10 a.m. and then to Parliament Hill starting at 2 p.m.*

2. *Dave Freedom fully intends to act peacefully and lawfully during protests. Dave Freedom Was going to Ottawa to express matters that have an important public message at a symbolic location. That important public message is his concern over the COVID-19 measures; vaccine mandates and travel restrictions. Dave Freedom has flyers which he wants to hand out from his vehicle and a speaker that he wishes to use to share that message.*
3. *The Ottawa Police Services have officially notified the public of a "vehicle exclusion" zone in the downtown core of Ottawa that will permanently prohibit the use of vehicles illegally parked, stopped or drivers who do not follow police directions will be fined, towed, and will result in arrests and charging of drivers.*

4. *The police have no legislative authority under the Highway Traffic Act, S 134.1 or under the Criminal Code Canada, Part II, S63(1) or any other legislative authority to permanently shut down the roadways to impede peaceful protests.*
5. *And police are prohibited from taking such actions as these acts would violate the Canadian Bill of Rights, 1960, the Recognized and Protected right of the individual of (d) freedom of speech and of S1(e) freedom of assembly and association.*
6. *To provide some context, I've always been passionate about maintaining our Human Rights and Fundamental Freedoms in Canada. I've had tremendous support from the community and mutual respect from police officers who got to know many of us who took part in peaceful demonstrations at Queens Park Toronto. However, on February 6<sup>th</sup>, 2021, with no evidence, my right to peaceful protest was violated when I was arrested at Queens Park for 'common nuisance' in violation of the Covid-19 measures. I was taken into custody and placed in a court service truck with my hands cuffed. Behind my back for close to 3 hours and in pain. My speaker equipment was also confiscated, and my rights were further violated with unreasonable restrictive bail conditions. Some of these conditions included being banned from the downtown core, not being able to possess sound equipment, hold a microphone and most importantly free speech and assembly.*
7. *Once my trial hearing was set for March 3<sup>rd</sup>, 2022, I made an application to dismiss for violations of the Canadian Bill of Rights, 1960 s1(b), the right of the individual to equality before the law and the protection of the law, s1(d) freedom of speech and s1(e) freedom of assembly and association. The week before the preliminary hearing, the crown submitted pleadings and on the day of the hearing, the crown withdrew my charge. I was very pleased that the court upheld my right to protest. It was my intention to participate in Rolling Thunder on April 29<sup>th</sup> to May 2<sup>nd</sup>, 2022 and other ongoing protests in the Ottawa downtown core in my vehicle in order to pass out flyers educating people on how they can get involved in various social actions regarding mandatory vaccinations. I learned that Chief Bell issued a statement where there was a permanent ban on vehicles protesting in the downtown core.*
8. *Freedom of speech, assembly and association without discrimination are critical rights because without the we have no capacity to maintain our rights.*

# Ottawa Police Statement on Rolling Thunder

(Ottawa) - The Ottawa Police Service has developed an enhanced operational approach to manage the Rolling Thunder event scheduled for April 30th along with any impacts from the arrival of participants on April 29th.

We have heard the concerns of the community. Since February, we have adjusted our overall approach to all demonstrations, protests, events and rallies.

The right to lawful and peaceful demonstrations will always be protected.

We will not allow for unsafe or unlawful conditions that could lead to another unlawful protest as seen in February.

**Vehicle exclusion zones:** As a result of the unlawful protest, the City of Ottawa's position is that no motor vehicle protests, rallies or events will be allowed in the designated downtown core areas. The Ottawa Police is supporting and enforcing that decision. This includes areas near Parliament Hill and the National War Memorial and applies to all demonstrations, rallies and events. All motor vehicles will be prohibited from participating in any of these events in these designated areas.

**Increased police presence:** We will receive significant, additional resources from multiple partner agencies including the RCMP, OPP and municipal police services. The focus of these resources will be on public safety, maintaining the right to protest and enforcing all applicable laws.

**Organizers:** Any organizer of any event will be held accountable for their actions before, during and after events.

**Online comments:** We continue to monitor online and open source commentary



related to all events. Threatening or intimidating behaviours will be investigated and subject to charges where warranted.

**Investigations:** Investigative teams, including our Hate Crime Unit, are in place focused on gathering evidence and laying charges. We are also in contact with the Crown Attorney.

## **Charter of Rights and Freedoms**

As a police service, we will always protect the rights of individuals to lawfully and peacefully protest in line with the Charter of Rights and Freedoms. Since the removal of the unlawful protest we have worked to ensure more than 100 protests could occur lawfully and peacefully in the core.

As we do with all events, we have reached out to Rolling Thunder organizers to ensure we understand their plans. We do this for every event from football games to rallies to demonstrations. This is not meant to support any specific cause but to ensure there are clear lines of communications and that public safety issues are addressed.

The role of police is to remain impartial, promote public safety and enforce relevant legislation.

We are also reaching out to individuals and groups who plan to express their opposition to this event through protest to understand their plans. As with all events, demonstrations and protests everyone will be treated equitably.

## **What residents can expect**

We will continue to communicate through this event to ensure everyone can make informed decisions.

Residents and businesses should expect traffic delays. Areas may be restricted to pedestrian-only zones in the core to maintain public safety. We are aware of a site in the rural area of Eagleson Rd. where some Rolling Thunder participants are gathering this weekend. This area will see increased police presence and possible traffic delays.

We are working with our City partners to develop a traffic plan and maps that will manage vehicular traffic and ensure safe movement of pedestrians. There will be allowances made for local traffic. Controlled intersections, road closures, vehicle towing and ticketing will be part of the enforcement strategy to support public safety.

In line with the Charter of Rights and Freedoms, ALL lawful protests, demonstrations and rallies etc. will continue to be allowed in the downtown core in areas such as Parliament Hill and the National War Memorial. Vehicles will be excluded from participating in any of these events.



Extra police resources from multiple police services have been requested to manage public safety, assist with road closures and enforce all Criminal Code, Bylaws and provincial Highway Traffic Act offences.

### Ottawa at Work with Leslie Roberts – transcript of interview

Leslie Roberts (Transcript starting at 0:55 of recording):

I am well. I'm anxious to get your reaction to all these developments, rumors and set the record straight. First and foremost, they say they had a deal to be able to do, among other things, a role, so in other words, on their bikes past the War Memorial, they said they would not include Wellington. As you hear what they are claiming - How much of it is true; how much of it is made up?

OPS Chief Steve Bell:

Yeah. Thanks, Leslie. And I, I do appreciate you bringing us on. So we can actually get the information out about how we're looking to progress through the weekend. What I can tell you is we've been planning for this from the time that we first became alerted to it through social media and through the Internet. And we've been in contact with the organizers and had discussions with them. What I can tell you at the same time is we've actively been working with the city. We've been working with other our partners, our community in that area to take a look at what is the best way that we manage, facilitate protest demonstrations and rallies moving ahead, particularly as they relate to vehicles. So what you've seen since the end of the occupation in February is there won't be vehicle-based protest rallies or demonstrations in the footprint that we have identified since South of Laurier. So we continue to get that message out to the organizers and we're having discussions with them about looking to identify what is the safest, most effective way for them to actually attend the War Memorial on foot to be able to go into that zone that doesn't have vehicles, and have their ceremonies while we facilitate the safe movement of vehicles through the city?

Leslie Roberts:

OK, so let's talk 1st about the zone. Is it similar to the one that was off limits during the occupation?

OPS Chief Steve Bell:

So I actually think what is most similar.. most similar to is the footprint we would have on Remembrance Day or the footprint we would have on Canada Day, where we also don't allow vehicles down into the core of the downtown. So it will go, it will go basically from the canal to Lyon St and then North from the river to Laurier St and that that is a that is a typical zone for us in Ottawa in order to be able to allow people to walk around and allow people to move in about an area and not have them come in conflict with vehicles.

Leslie Roberts:

So to answer my first question: There will be no roll by or roll through the War Memorial. It'll be off limits regardless of whoever the protester is.

OPS Chief Steve Bell:

Yeah, absolutely. So we we have, we have identified that based on what's occurred in our city over the last number of months, that protest vehicle based protests shouldn't occur in that area. And we've put exclusionary zones in now.

Make the really important thing to remember in that is, we're a city that hosts hundreds of protests a year, so we're we're a city that at a police service that absolutely understands the, protects people's right to lawfully demonstrate. We will continue to do that. People can attend the War Memorial, we encourage them to. It'll just be on foot. So you can they drive through centre town with their engines, you know, making the noises that motorcycles do.

Going to facilitate that if they're roaming around neighborhoods, creating public safety concerns or issues, we are going to use our enforcement abilities to do that. One of the really important things we have to remember about this is our communities are scarred by what happened in February. They were deeply hurt and deeply affected by that. We as a police service myself as the chief, have had many conversations with them. They expect us to make maintain community safety and well being in their areas, and we're putting plans in place to make sure we.

So what you're gonna see over the weekend is your first of all, you're going to see absolute accessibilities for pedestrians to attend the downtown core. But you're also going to see traffic disruptions. There will be.
