RE: CANADIAN WOMAN DENIED LIFE SAVING ORGAN TRANSPLANT OVER HER VACCINATION STATUS

Honorable Premier Smith,

We were pleased to hear about your appointment as premier of Alberta, because of your public statement of concern about the discriminatory treatment of persons who are unvaccinated.

You have committed to change the human rights code to prohibit discrimination based on vax status. We do have a right to protection from this type of discrimination under the Alberta Bill of Rights section 1(b), unfortunately, this only applies to government. Your changes would make it a requirement that everybody respect this right to privacy and informed consent.

We understand that you are encouraging organizations and businesses to voluntarily remove their proof of vaccinations policies before the changes to the human rights code are implemented.

On behalf of a Canadian citizen of Alberta, Sheila Annette Lewis, Stand4Thee would like to draw your attention to Sheila, who has been denied a lifesaving organ transplant in Alberta over her vaccination status.

We are asking for your immediate intervention in support of Sheila Lewis to receive a lung transplant. And that this intervention takes place without delay because she doesn't have a lot of time left to live without this lung transplant.

Discrimination towards Sheila is from the Alberta Health Services, the University of Alberta, and several doctors that were involved in making the decision.

She is the mother of 4 boys with 2 grandbabies, that all depend on her love and support. Her only wish is to get her much needed transplant so she can continue to live her life and enjoy her family.

Sheila has been a hard worker all her life until 2019 when she fell ill and began her battle with Pulmonary Fibrosis, a condition which is extremely deadly and can require an organ transplant for survival. In Sheila's case, she needs a life-saving lung transplant and has been on the waiting list to receive a lung transplant since September 2021.

At the point where she can no longer work approximately three years ago, she applied for Assured Income for the Severely Handicapped and has not yet received any payment, and in fact, has had no income for this time. We would like assistance for this matter also.

The Justice Center for Constitutional Freedom (JCCF) filed a constitutional challenge for Sheila against the doctors who made the decision that she cannot get the transplant without having taken all 5 available vaccines. The issue here is that an Alberta Judge ruled that doctors are not covered under the Charter and therefore the decision to deny her a lifesaving organ donation did not violate her Charter rights.

Sheila tried to get the JCCF to initiate another action against the Alberta Government and the University of Alberta using only the Alberta Bill of Rights and the Implied Bill of Rights, but they refused and aggressively pushed her to continue with an appeal using the Charter going after the doctors only. The Judge has ruled that the Canadian

Charter Rights and Freedoms does not apply in this case and Sheila must follow the policy that every patient who needs an organ transplant must be vaccinated to receive treatment.

The Alberta Bill of Rights section 1(a) protects Sheila's right to liberty and security of person and section 1(b) of the Bill protects her right to equal treatment and equal protection of the law. In this case, we have categories of persons, vaccinated and unvaccinated being treated differently. Sheila is being unfairly and unreasonably left to die.

The policy they are applying to Sheila to deny her life-saving lung transplant if she chooses not to have a vaccination is unlawful because it contravenes Alberta Bill of Rights, the Implied Bill of Rights, and the Canadian Bill of Rights.

Premier Smith, on October 11, 2022, you have acknowledged that "unvaccinated people are the most discriminated against group", and we hereby humbly request you to investigate this very important issue and we would like to thank you in advance for resolving this case and responding by protecting Alberta citizens' rights to receive medical treatment without discrimination based on vax status.

We are calling on you to take action to resolve this matter in the form of facilitating a lung transplant for Sheila Lewis as soon as immediately possible as well as instate Alberta disability payments for her.
