

## #TRUDEAU4TREASON AFFIDAVIT

Prime Minister Trudeau committed treason by illegally invoking the Emergencies Act (EA) against peaceful and lawful protesters. Because of the invocation of the EA the protestors and their supporters were attacked violently during the 2022 Freedom Convoy and charged criminally for exercising their right to freedom of speech and assembly and association. The protestors who were opposing his mandatory vaccine restrictions on travel.

### Facts:

- There were no grounds as per section 3 of the Emergencies Act because the protest was lawful and peaceful.
- There was no permission from parliament as required by section 17.1 of the Emergencies Act. There was only a vote on a motion to table a vote for confirmation of the invocation at the 7th day mark.
- The invocation of the Act violated rights under the Canadian Bill of Rights. The participant's and supporter's right to freedom of speech and assembly as well their legal right to protest were violated when excessive violence was used by law enforcement, contrary to paragraph 3 of the Emergencies Act.

### Purpose of This Affidavit:

We are gathering formal evidence from participants and protesters of the 2022 Freedom Convoy. This evidence will be used as part of the incident report and an information that will be submitted to the RCMP, the MPs and the Senators to request criminal charges be laid for Trudeau and his cohorts. The affidavit needs to be commissioned/notarized to make it legally binding, this can be done in person or via zoom. We are offering an open Zoom where we will have licensed paralegal Jane Scharf available to commission your affidavit on Thurs, Oct 6 @ 8PM(EST). ### Who Can Complete an Affidavit:

Anyone who was protesting/participating in the convoy or attended as a supporter and would like to make a statement regarding what they experienced/observed.

### What to Include in the Affidavit:

This is a statement of claim, a legal binding document, of your experience. It's a recount of the events that will be used as evidence. Keep it short and simple.

This is your story, your recount of events or your own opinion on the convoy and what it meant for you and how it impacted you. You can expand on your experience as you want. As there may not be enough room in the affidavit template (this is a formal court document template) feel free to type/write out your affidavit in a separate document and write "Appendix A" as a header on the page and also number each page. Then in the space on the affidavit where you are to write your statement, write "See Appendix A". Then attach the appendix to the end of the last page of the affidavit template.

Please number each paragraph in your affidavit. If you have 3 paragraphs, the first paragraph is numbered "1", the second paragraph is numbered "2", the third paragraph numbered "3", etc. as per the example below.

Here is an example:

1. On Feb 16th, 2022, around 5PM (EST) I was standing on Wellington St and the corner of Bank St. I observed that there was a single lane and intersection open for emergency vehicles. Sidewalks were also clear for pedestrians. I did not observe any violence or criminal activity from protestors or supporters. What I did observe was a peaceful and lawful protest. There were families walking through the streets and everyone was respectful and peaceful.



2. On Feb 18<sup>th</sup>, 2022, around 9am in the morning I was walking Eastbound on Wellington to meet a friend at his truck. As I neared his truck I noticed a group of people standing together, then saw a line of police wearing green uniforms who had created a human parameter around the area and were preventing people from getting close to the trucks. I witnessed the police smashing out windows and violently arresting men who were in their trucks, unarmed and were not violent nor aggressive to the police.

### **Submitting Evidence Artifacts (photos/videos):**

If you have supporting evidence to submit with your affidavit, please post it on a drive (Google, One Drive, etc) or a hosting service like Archive.org so you can include it in your affidavit as a hyperlink. All the evidence should be accessible through the affidavit itself.

### **Questions as Thought Starters:**

- Did you observe the protestors left at least one lane open on the road(s) you were on?
- Did you observe the intersections were left open by the protestors/supporters?
- Did you observe that the protestors left the sidewalk clear for pedestrian passage?
- Did you observe the police blocking the roads and/or intersections?
- Did you observe any violence by protestors or supporters during the convoy?
- Did you observe any criminal activity committed by the protestors or supporters during the convoy?
- Did you see positive interactions between protestors, supporters, police, business, etc., and if so please describe.

### **Commissioning/Notarizing Your Affidavit:**

1. There are three different methods for commissioning/notarizing:
  - a. In person, this is the first option for signing and you only use this if you are doing the signing in person.
  - b. Via video, in the same city. This is the second option for signing.
  - c. Via video, in different city. This is the third option for signing.
2. Do not sign where it states "Before me" that is for the commissioner/notary to sign – DO put in the date!
3. Do not sign before being witnessed!
