AMENDMENT TO THE DILLES AND DECLI

THE RULES AND REGULATIONS OF RIVERVIEW CONDOMINIUMS DECLARATION

THIS AMENDMENT is made this 7th day of <u>February</u>, 2024, by Riverview Condominiums Owners' Association (the "Association").

WITNESSETH:

The Association hereby amends the Rules and Regulations of Riverview Condominiums (the "Rules and Regulations") for the purpose of establishing that grills, smokers, hibachis, other outside cooking appliances, and related components, including but not limited to propane tanks, grill covers and utensils, shall not be operated and/or stored in the Units, on the Common Elements and Limited Common Elements of the condominium.

RECITALS:

WHEREAS, pursuant to Article XIII, Section 8.6 of the Riverview Condominiums Declaration recorded on April 25, 2006 in Book 1342 at Page 69 in the Town of Lincoln Land Evidence Records (the "Declaration"), the Rules and Regulations shall be amended with a two thirds majority vote of the Executive Board;

WHEREAS the Executive Board desires to amend the Rules and Regulations to establish that grills, smokers, hibachis, other outside cooking appliances, and related components, including but not limited to propane tanks, grill covers and utensils, shall not be operated and/or stored in the Units, on the Common Elements and Limited Common Elements of the condominium;

WHEREAS, the Executive Board by a two thirds majority vote of the members of the Executive Board, have voted to amend the Rules and Regulations for the above stated purpose, as certified below.

AMENDMENT:

NOW, THEREFORE, in accordance with the above-noted provisions of the Declaration, the Rules and Regulations are amended by striking Section (q) in its entirety and substituting the following therefore:

(q) Grills, smokers, hibachis, other outside cooking appliances, and related components, including but not limited to propane tanks, grill covers and utensils, shall not be operated and/or stored in the Units, on the Common Elements and Limited Common Elements of the condominium, including but not limited to balconies. Balconies shall be maintained in a neat and attractive condition. No trash barrels may be stored on the balconies.
