



VENDOR AGREEMENT

The "Vendor" hereby agrees to:

1. Pay the NON-REFUNDABLE VENDOR FEE according to package choice.
2. Promote the services of their sole business (as stated below) and will not share table space nor promote the services of any other business in any way. Company "umbrella" businesses are not permitted.
3. Complete setup of display 1 hour before event begins. All vendors will be responsible for set up, cleanup of area, and break down of merchandise.
4. Have space supervised by qualified individual at all times while open to public. All staff representatives will promote their services within the confines of their table ONLY.
5. Complete, sign and return this contract along with your deposit fee upon acceptance of terms. To guarantee a table at the event, fee must be paid in full by August 26th.
6. All certified checks or money orders can be made payable to Once A Dream Foundation . You may visit www.WeWINFest.com to pay by credit or debit card.
7. All food truck vendors must be registered under Nashville Parks and Recreation. The online application can be submitted here: <https://www.nashville.gov/Parks-and-Recreation/Permits-Rentals-and-Reservations/Food-Trucks/Food-Truck-Permit.aspx>
8. Vendors are solely responsible for all transactions between buyer and seller.
9. Vendor is responsible for all sales between seller and buyer and in no event will Once A Dream Foundation and Powerhouse Nashville be liable for any loss of profit.
