### WIC FMNP VOUCHERS

- WIC participants may be eligible to receive a one-time per year \$30 voucher booklet, while supplies last on a first come, first serve basis.

- Pick up your vouchers at any Get Moving Houston Farmers Market with a current WIC shopping list.

- Vouchers can be used to purchase fresh fruits and vegetables only.
