WHEREAS, the Annual Budget for Gloucester Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2025 and ending December 31, 2025 has been presented before the Board of Commissioners of the Fire District at its open public meeting of November 12, 2024; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$588,619.00 which includes an amount to be raised by taxation of \$451,450.00 and Total Appropriations of \$588,619.00; and

In the proposed budget for 2025, anticipated revenues and appropriations will decrease by \$87,138.33 as compared to the 2024 adopted budget as modified by Chapter 159. This is a 12.9% decrease. On budget pages F-2 and F-3 and the associated appropriation detail pages, certain individual lines are reflecting a variance with the prior year adopted budget in excess of +/-10%. These are explained in item 3 below.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

PAGE F-2: Unrestricted fund balance utilized in 2025 of \$122,385.00 is more than the amount in 2024 of \$90,840.00 by \$31,545.00, 34.7%. This variance is the net result of variances in revenues and appropriations that is explained in detail next. Interest earning anticipated in 2025 \$3,000.00 is less than the amount in 2024 of \$6,000.00 by (\$3,000.00) (50.00%) resulting from changing interest rates. The FEMA Safer Grant in the 2024 adopted budget ended in 2024 resulting a reduction for the proposed budget of (\$49,433.33) (-100%) with this same reduction in appropriations on page F-3. In addition, by way of Chapter 159, the American Rescue Plan Firefighter Grant was added to the 2024 Budget and not repeated resulting in a reduction in the proposed budget of (\$75,000.00) (-100%) with this same reduction in appropriations on page F-3. On Page F-3, Fringe benefits under administration and the cost of operations of \$4,752.00 are \$509.14, 12% more than in the adopted budget resulting from life insurance premium increases. There is a decrease in Interest Payments of Debt of (\$600) (-17.6%) on the loan financing for the fire truck purchase due to the schedule of loan payments. On F-3 (Detail), maintenance and repair is expected to increase \$17,000.00, 36% due to plan repairs needs; general supplies will decrease (\$600), (100%) where U.S.F.A. Office Supplies will increase \$600, 66.7% due to a change in needs; U.S.F.A. Training will increase \$400, 100% with no planned training in the adopted budget and Fuel and Equipment for Squad 88 will increase \$6,000, 100% as it was not budgeted separately in the adopted budget. For other assets non-bondable, matching funds for grants and the cost of a grant writer will increase \$3,476.67, 62.9% due to plans for grant applications and as stated previously, the 2024 budget included two grant programs that were not reported in the proposed budget resulting in a decrease of (127,010.00), (100%) for the grants and the local match.

The amount to be raised by taxation in the 2025 budget of \$451,450.00 is a \$8,850 increase over the \$442,600.00 in the 2024 adopted budget. The projected tax rate (three decimals) of \$.122 is an increase of \$.003 from the 2024 adopted rate of \$.119. The 2025 budget will utilize \$122,385.00 unrestricted fund balance and is \$31,545 more than the amount utilized in the 2024 adopted budget and will decrease undesignated fund balance by 33.0%.
