#### Terms and Conditions

When your pet receives services at Glamour Grooming & Boarding, the following Terms and Conditions apply:

All clients must fill out a Hold & Harmless for each pet

New clients must fill out a client profile sheet

Shots records are required

Please bring your fur baby fully vaccinated with shot records showing Distemper, Parvo,

Rabies, Bordetella, H3N2/H3N8 (Canine Influenza) vaccinations and with leash/collar.

Please bring bedding/mat/blankets/dog food for all boarding services

Please be on-time for your appointment

Do not feed pet 10 hours prior to all grooming services

All pets must arrive by 11:00AM

All pets must arrive with collar/leash

Pet pickup is NO LATER than 1 hr. and 30m after completion of services and (please answer the  $\ phone!$  )

After 3:30, a \$25 late fee or boarding fee will incur

Any pickups for boarding after 1p the following day will incur an additional

overnight stay

Food can be provided for all daycare/boarding services for an additional \$5

daily

We have the right to refuse services for any vicious or aggressive dogs or charge a fee not more than 10% according to the severity of injury to the handler and/or groomer



# PET PROFILE MATTED DOG RELEASE FORM

The need to remove matted hair is a necessity. When a coat becomes tangled beyond the ability to brush or comb through it, the most humane method is to clip off the matted hair. Clipping may seem severe, but it is the fastest and least stressful way to groom a matted pet. Clipping is an option that is not taken lightly due to the wear and tear this can also cause on grooming equipment such as clipper blades, causing them to become blunt after dirty clipping, and scissors.

Matted coats can cause the following problems:

- Skin irritation caused by dirt, dander, and parasites trapped under the matted hair. Sores and hair loss; As mats get tighter, they eventually pull out of the skin, causing bald spots and sore skin/abrasions.
- In severe cases, maggots can infest skin sores.
- It is not uncommon to find pre-existing conditions such as hot spots, sores, and other skin issues once the matted coat has been removed. There is a chance that your pet's skin may become irritated from being clipped so close.
- Ear bruising due to the excessive head shaking after removal of the mats can occur and from the removed hair inside the ear.

Because the procedure takes extreme care and extra time, there will be additional charges depending on the severity of the matting.
