- This creates difficulties when outside organizations use automated or AI-based systems to verify nonprofit status.

### **Grant Agency Approval Status**

- Has been put on hold.

### **Chamber of Commerce**

- Chamber of Commerce membership was placed on hold for Q3.

### **Lions Club / Rotary**

- Has been put on hold until solicitation licenses are complete and approved.
