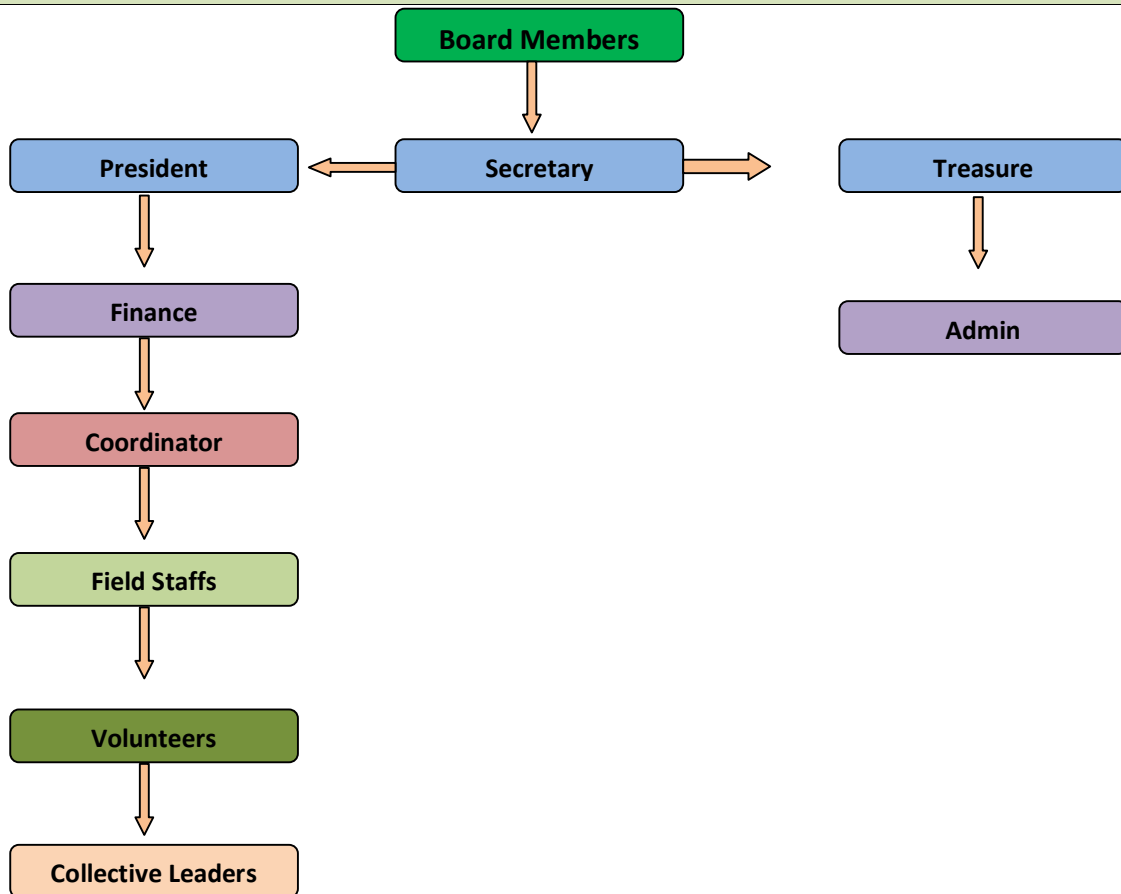

**Strategies / Plan to address and resolve the issues identified**

- The issues of reporting, documentation, communication skills maintenance of MIS, proposal writing, financial and admin
- Issues will be somewhat addressed and resolved by organising capacity building workshop as per the second year plan. After the workshop the improvement in their reporting and documentation will be assessed monthly and quarterly accordingly handholding support will be planned.
- Strategic thinking and approach will be adopted to augment visualise CLOs leadership identity from district to State level.
- Participatory approach for nurturing tribal leader’s collectivism by the CLOs in assistance with mentor and Project Officers and Consortia will be planned.
- Handholding support in documenting and highlighting best practises of CLO work.
- Capacity enhancement program for upgrading legal literacy among staffs and CLOs will be organised by the Project.
- Orientation to conduct situation analysis before developing any proposal will be organised By Social Inclusion Project / mentors and Consortia.
