



NON-MEMBER PARTY CONTRACT

Initial

This agreement is made between TERRA DEL SOL AQUATIC CLUB (TDSAC) and \_\_\_\_\_ (the Host). The party to which this agreement pertains will occur on \_\_\_\_\_. CANCELLATION POLICY

Cancellations are free 72 hours prior to your reservation. Your Facility Rental is forfeited if canceled within 72 hours.

TDSAC lifeguard rate is \$20.00 per hour. There will be one guard for every 25 people. **THE GUARDS WILL BE PAID IN CASH OR CHECK PRIOR TO THE START OF THE PARTY.** The party guard will be responsible for helping the sponsor set up, taking items in and out of the office, guarding the pool, advising guests of our rules and regulations, solving any problems that may arise and help with the cleanup.

\*This fee is based on a 3-hour party. Additional hours incur a \$25 per hour charge.

TDSAC agrees to provide the following facilities and party equipment. The use of the large Ramada, small Ramada, tables, chairs, charcoal grills (charcoal and lighter fluid will be provided by the sponsor), refrigerator in the office, plastic trash bags for waste containers, and a separate can for collection of aluminum cans. **The Host agrees that only aluminum cans will be placed in the container marked "aluminum cans." Glass is not allowed.**

TDSAC agrees to have the Ramada clean at the time the party begins. The party guard will open the back gate for the Host to unload and load items for the party. The Host, with the help of the party guard, is responsible for setting up tables and chairs for the party and for taking them down and returning them to their storage area unless otherwise notified by the party guard. The Host agrees to pick up and bag all trash at the conclusion of the party, including any trash in the bathrooms. **The Host will not have exclusive use of the pool itself during pool operating hours as the pool is also available for members' use.**

The Host agrees to be physically present throughout the party and to be responsible for the behavior of his or her guests. The Host and guests are to follow all rules of the pool, a copy of which is listed at the pool and attached to the agreement. The lifeguard on duty at the pool will have the ultimate authority to discipline or eject any guest whose behavior is disruptive, destructive, or creates danger for other guests. The lifeguard also has the ultimate responsibility for the safety of all people, including weather-related issues. **Fifteen minutes out of every hour is dedicated to adult swim which allows rest for the children and guards and time for adults (18 and older) to enjoy the pool.**
