

## **Millview Terms and Conditions 2018**

Hello, Millview Members! This is a document that provides a basic agreement between all members and the board at Millview (who are also members). This is not intended to be a long, legal contract that few would read or even understand. Instead, it is intended to make all aware of what Millview Swim Club *is*, and what it is *not*, and how it is operated. What can you expect by joining our community-run pool?

- 1) **We now have a pool maintenance company to keep the pool clean and clear.** This still requires the participation from members to keep it beautiful!
- 2) This is a “not for profit” organization, and we receive no financial assistance from the city, county or state.
- 3) This is a volunteer organization. We depend on the help of members to make the workload light. The board does not get paid for their service to Millview, but receives a nominal discount for membership dues the following year.
- 4) Who is the “board of directors” at Millview? The board of directors is made up of: President, Vice-president, Treasurer and Secretary. Additionally, in 2018 we are introducing an organizational structure that includes approximately 12 other board members, each of which have a specific area/task to manage at the pool. The structure of the board, including names, will be made available to members before the opening day. For privacy, this will not be listed on the website, but emailed to members.
- 5) What benefits do the board members receive? After serving on the board for one season, board members earn a discount of \$100 off the full membership price for the following year. They must have been active and effective in their role, determined by the board and themselves. The president does not pay for his/her family membership.

## **2018 Community Club Standing Rules**

All members, employees and guests are to maintain the safest environment possible. To this end, everyone must follow all rules as stated in the charter, bylaws and general information notebook of Millview Swim Club, as well as any posted on the property.

1. No trespassing is allowed by non-members at any time.
2. Anyone, members included, found on the property after hours without permission will also be considered trespassing.
3. No solicitation.
4. Improper or unsafe use of any Millview facility will be grounds for removal from the property.
5. The phone is for emergency use only.

6. Only family members living in the same household share privileges of membership.
7. Members are limited to five (5) guests per visit, if those guests are not from one single family. (More than five would be a party, and must be approved by the President).
8. Guest fee is \$3.00 per person per visit. Please encourage friends to join Millview!
9. Each member family is granted one gate key, no exceptions.
10. Admittance to pool requires member's key. This is proof of membership. Lifeguards are not to let members in if they forget their key. They are not to abandon their post.
11. Keys are never to be given to any non-members, except in the case of baby-sitters bring members' children.
12. There is a \$50 fee to replace a lost key.
13. The information on clubhouse rental and party regulations are described in a separate document to be available on the website . Please direct inquiries to [millview@millviewswimclub.com](mailto:millview@millviewswimclub.com) or call (615) 994-1133.
14. Please respect your community club by picking up your own trash.
15. Please be sure to sign the member log-in register each day.
16. Membership implies consent for photos to be placed on MillviewSwimClub.com unless written refusal is provided *within one week of purchasing your membership*.
17. Hours of operation will be maintained on the website, and are subject to change throughout the season as determined by the Millview Board of Directors. Hours may be increased, decreased, shifted depending on input or trends of use from members.
18. If no members are present one half-hour before closing, the guard may elect to shut the pool down fifteen minutes early.
19. Hours subject to change in inclement weather.
20. Hours will change when Williamson County Schools open in August.
21. Lifeguards are on duty; however, it is the ultimate responsibility of parent(s) to ensure Safety of your child or guests you may bring with you.
22. Lifeguards are charged with the responsibility of enforcing the rules.
23. Swimming attire only, cutoffs are prohibited. Please make sure swim suits are pool-use only. **Algae/mold problems can be caused by contamination from creeks, lakes, etc.**
24. Use of BABY POOL is restricted to children 6 years of age and under – parents are responsible.
25. For the safety of children in the baby pool area, NO ADULTS are to be in the BABY POOL on a float, when children are present.
26. Smoking is prohibited on premises.
27. Use of alcohol or illegal drugs are *strictly* prohibited on the property.
28. Lifeguards will request anyone using foul language to leave the premises.
29. Inclement weather and closing the pool is at the discretion of the Board.
30. Lifeguards may, at their discretion, require a swim proficiency test for any age swimmer.

### **Rules Specific to Millview's Swimming Pool 2018**

1. No running on the pool deck.
2. No chicken fights.
3. No floating devices in the diving well (deep end).
4. Back dives and flips are allowed at the discretion of the lifeguard(s). Unsafe techniques may be barred if they are perceived to be risking the safety of any person.
5. No diving in the shallow end.
6. No jumping from the lifeguard stand.
7. No food in the pool area. Including items purchased from the Snack Shack.
8. No music with offensive content. Volume should stay at a moderate, common-sense level.
9. In case of lightening, all members must leave the fenced pool area until there has been no thunder for thirty (30) minutes. Members may wait under the pavilion.
10. Swim diapers are required for young children who are not fully potty-trained. Parents, please use your best judgement on this. Even children who may have entered the stage of self-control in this area might wait until it's "too late" if they are swimming and having a great time.
11. Only plastic cups (with lids), or plastic bottles are allowed in pool area. Broken glass in the pool area requires the entire pool to be drained and vacuumed. This is a huge expense (chemicals, water and labor), as well as several days of the pool being shut down for all members.
