COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread from person-to-person contact. Federal, state, and local governments and health agencies recommend social distancing and have, in many areas, prohibited group activities.

SVC Sarasota Volleyball is taking steps to reduce the spread of COVID-19; however, SVC Sarasota Volleyball cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending SVC Sarasota Volleyball activity could increase the risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending SVC Sarasota Volleyball activity and that such exposure or infection may result in personal injury, illness, permanent disability, and death.
