Mr. Yax,

We understand your medical condition prohibits accurate memories of all events including the one you reference below. Here is the proper event description ... directly from our clinic's medical log. This event was and still is the most severe client reaction in our clinic's 5 year history, now having performed over 240,000 sessions.

Eric Yax (46, 320lbs, 6'-4") failed to fill out our clinic's Services Application properly and completely, withholding critically important information about his medical condition and medical history. We provided him a session on a red light device targeting lipolysis (fat loss) that over 200 other clients had used (totaling several thousand sessions) with excellent success and without incident. Yax's treatment duration and tissue distance from the lights were consistent with the thousands of other treatments for our other clients.

As the result of the anti-psychotic medication Yax was taking at the time, he was hyper-sensitive to light in general. This condition and sensitivity would have been presented by his healthcare provider to Yax and it would be expected that exposure to any light, including the sun, would generate a similar response.

Yax eventually walked out of the treatment room into a restroom where he stayed another 15 minutes. He then walked out of our clinic after a brief discussion about properly presenting medical conditions on clinic services applications.

Even after this event, Yax continued to withhold critical medical and drug addiction history that would negatively impact both the potential efficacy and result in potential negative impact to his own health from all treatments performed by a Biophotonics Clinic.

Leora, who has no formal medical training and no medical experience, for a short period of time was being trained to potentially manage a Wellness, etc. clinic, but she failed to follow our protocols and instructions so her engagement and agreement was terminated.
